- 01 The car parking at Basement, froor area shall have adequate safety measures. It shall be done entirely at the risk and cost of owner. BBMP will not be responsible for any kind of damage, losses, risks etc., arising out of the same
- 02 The structural safety of building will be entirely at the risk and cost of Owner / Architect / Engineer / Structural Engineer and BBiMP will not be responsible for structural safety
- 03. He shall not add or after materially, the structure or a part of the structure there off without specific permission of BBMP. In the event of the applicant violating, the BBMP has the right to demolish the deviated / altered / added portion without any prior notice.
- 04. If any extra floor is added or built after obtaining occupation certificate, issued certificate will be withdrawn without giving any prior notice.
- so to to to the second 05. Basement floor parking should be used for car parking purpose only as per built plan.
- 06. Footpath in front of the building should be maintained in good condition.
- 07. Rain water harvesting structure shall be maintained in good condition for storage of water for non-portable purpose or recharge of ground water of all times as per Building Bye laws-- 2003 clause No. 32 (b)
- 08. Owner shall make his own arrangements to dispose off the debris / garbage after segregating it into organic and inorganic waste generated from the building, suitable arrangements shall be made by the owner himself to transport and dump these segregated wastes in consultation with the BBMP Zonal Health Officer.
- 09. In case of any false information, misrepresentation of facts, or pending court cases, the Occupancy Certificate shall be deemed to be cancelled.
