The Plan was sanctioned for the construction of Residential Apartment Building Block – 1, 2, 3, 4, 5 and 6 Consisting of GF+4 UF with Common 2 Basement Floors comprising of 434 Units (Including 45 EWS Units) at Property Khatha No. 7, Sy No. 23/1, Kammagondanahalli Village, Shettyhalli ,Ward No. 12, Yeshwanthpura Hobli, Bangalore North Taluk, Dasarahalli Zone, Bengaluru by this office vide reference (2). KSPCB vide Ref (4) has issued consent for Operation of Sewage Treatment Plant (STP).

The Proposal was submitted by the applicant vide ref (1) for the issue of Occupancy Certificate, the Residential Apartment Building was inspected by the Officers of Town Planning Section on 16-12-2021 for the issue of Occupancy Certificate. During inspection, it is observed that, the building is constructed as per the Sanctioned plan which is as per Building Bye-laws - 2003. The proposal for the issuance Occupancy Certificate for the Residential Apartment Building was approved by the Chief Commissioner vide ref (3). Subsequent to the Approval accorded by Chief Commissioner the applicant was endorsed on dated: 08-03-2022 to remit the Ground Rent Arrears and Scrutiny fee of Rs. 38,17,000,/-. (Rupees Thirty Eight Lakhs Seventeen Thousand only), has been paid by the Applicant in the form of DD No 667177 drawn on Kotak Mahindra Bank Ltd., dated: 09-03-2022 and taken into BBMP account vide receipt No.RE-ifms331-TP/000163 dated: 11-03-2022.

Hence, Permission is hereby granted to occupy Residential Apartment Building Block – 1, 2, 3, 4, 5 and 6 Consisting of GF+4 UF with Common 2 Basement Floors comprising of 434 Units (Including 45 EWS Units) at Property Khatha No. 7, Sy No. 23/1, Kammagondanahalli Village, Shettyhalli ,Ward No. 12, Yeshwanthpura Hobli, Bangalore North Taluk, Dasarahalli Zone, Bengaluru Occupancy Certificate is accorded with the following details.

This Occupancy Certificate is issued subject to the following conditions:

- 1. The car parking at Two Basement Floor and Part of Ground Floor area shall have adequate safety measures. It shall be done entirely at the risk and cost of the owner. BBMP will not be responsible for any kind of damage, losses, risks etc., arising out of the same.
- 2. The structural safety of building will be entirely at the risk and cost of owner / Architect / Engineer / Structural Engineer and BBMP will not be responsible for structural safety.
- 3. Owner shall not add or alter materially, the structure or a part of the structure there off without specific permission from BBMP. In the event of the applicant violating, the BBMP has the right to demolish the deviated / altered / additional portion without any prior notice.
- 4. Two Basement Floor and Part of Ground Floor area should be used for car parking purpose only and the additional area if any available in Two Basement Floor and Part of Ground Floor area shall be used exclusively for car parking purpose only.
- 5. Footpath and road side drain in front of the building should be maintained in good condition.

6. Rain water harvesting structure shall be maintained in good condition for storage of water and shall be used for non potable purpose or recharge of ground water at all times as per Building Bye-laws-2003 clause No. 32 (b).

- 7. Since, deviations have been done from the sanctioned plan while constructing the building, the security deposit is here with forfeited.
- 8. Owner shall make his own arrangements to dispose off the debris/garbage after segregating it into organic and inorganic waste generated from the building. Suitable arrangements shall be made by the owner himself to transport and dump these segregated wastes in consultation with the BBMP Zonal Health Officer.
- 9. All the rain water and waste water generated from the usage shall be pumped into the rain water harvesting pits and used for landscaping.
- 10. Garbage originating from building shall be segregated into organic and inorganic waste and should be processed Scientifically in the recycling processing unit of suitable capacity i.e. organic waste convertor to be installed at site for its re use / disposal.
- 11. This Occupancy Certificate is subject to conditions laid out in the CFO issued from KSPCB vide W-328235 PCB ID: 105839, dated: 20-11-2021 and Compliance of submissions made in the affidavits filed to this office
- 12. The Applicant / Developer should abide by the condition imposed during Occupancy Certificate.
- 13. In case of any false information, misrepresentation of facts, or pending court cases, the Occupancy Certificate shall deemed to be cancelled.

On default of the above conditions the Occupancy Certificate issued will be withdrawn without any prior notice.
