Bangalore by this office vide reference (2). The Commencement Certificate was issued on 17-12-2020. The Fire and Emergency Services Department has issued Clearence Certificate to Occupy Building vide Ref. No. (4). KSPCB vide Ref (5) has issued consent for Operation of Sewage Treatment Plant (STP).

The Proposal submitted by the applicant vide ref (1) for the issue of Occupancy Certificate for Commercial Building was inspected by the Officers of Town Planning Section on 10-01-2023 for the issue of Occupancy Certificate. During inspection, it is observed that, there is deviation in construction with reference to the Sanctioned plan which is within the limits of Regularization as per Building Bye-laws-2003. The proposal for the issuance of Occupancy Certificate for the Commercial Building was approved by the Chief Commissioner vide ref (3). Subsequent to the Approval accorded by Chief Commissioner the applicant was endorsed on dated: 18-04-2023 to remit Rs. 40,71,000/- (Rupees Forty Lakhs Seventy One Thousand only) towards Compounding fee for the deviated portion Ground rent arrears, GST, Scrutiny Fees and has been paid by the Applicant in the form of DD No.013877 dated: 15-04-2023 drawn on HDFC Bank Ltd., and taken into BBMP account vide receipt No.RE-ifms331-TP/000004 dated: 18-04-2023 The Deviations effected in the Building are condoned and Regularized accordingly. Hence, as per provision of section 3.13 (ii) of Zonal regulations of RMP – 2015 & clause 4.15 (2) of Building Bye-law – 2003, the security deposit paid during approval of building plan and modified plan is hereby forfeited. The Deviations effected in the Building are condoned and Regularized accordingly.

- 1. The car parking at Basement Floors, Part of Ground Floor and Surface Area shall have adequate safety measures. It shall be done entirely at the risk and cost of the owner. BBMP will not be responsible for any kind of damage, losses, risks etc., arising out of the same.
- 2. The structural safety of building will be entirely at the risk and cost of owner / Architect / Engineer / Structural Engineer. BBMP will not be responsible for structural safety.
- 3. Owner shall not add or alter materially, the structure or a part of the structure there off without specific permission from BBMP. In the event of the applicant violating, the BBMP has the right to demolish the deviated / altered / additional portion without any prior notice.
- 4. Basement Floors, Part of Ground Floor and Surface Area should be used for car parking purpose only and the additional area if any available in at Basement Floors, Part of Ground Floor and Surface area shall be used exclusively for car parking purpose only.

- 5. Footpath and road side drain in front of the building should be maintained in good condition.
- 6. Rain water harvesting structure shall be maintained in good condition for storage of water and shall be used for non potable purpose or recharge of ground water at all times as per Building Bye-laws-2003 clause No. 32 (b).
- 7. The area reserved for Lake & Nala Buffer as per the sanctioned plan by this office should not be deviated for other purpose and should not be encroached.
- 8. Since, deviations have been done from the sanctioned plan while constructing the building, the security deposit is here with forfeited.
- 9. Owner shall make his own arrangements to dispose off the debris/garbage after segregating it into organic and inorganic waste generated from the building. Suitable arrangements shall be made by the owner himself to transport and dump these segregated wastes in consultation with the BBMP Zonal Health Officer.
- 10. The owner / Association of high-rise building shall obtain clearance certificate from Fire Force Department every two years with due inspection by the department regarding working condition of Fire Safety Measures installed. The certificate should be produced to the corporation and shall get the renewal of the permission issued once in two years.
- 11. The Owner / Association of the high-rise building shall get the building inspected by empanelled agencies of the Fire Force Department to ensure that the fire equipments installed are in good and workable condition, and an affidavit to that effect shall be submitted to the corporation and Fire Force Department every year.
- 12. The owner / Association of high-rise building shall obtain clearance certificate from the Electrical Inspectorate every two years with due inspection by the department regarding working condition of Electrical installations / Lifts etc. The certificate should be produced to the corporation and shall get the renewal of the permission issued.
- 13. The Owner / Association of the high-rise building shall conduct two mock drill in the building, one before the onset of summer and another during the summer and ensure complete safety in respect of fire hazards.
- 14. All the rain water and waste water generated from the usage shall be pumped into the rain water harvesting pits and used for landscaping.
- 15. Garbage originating from building shall be segregated into organic and inorganic waste and should be processed Scientifically in the recycling processing unit of suitable capacity i.e. organic waste convertor to be installed at site for its re use / disposal.
- 16. This Occupancy Certificate is subject to conditions laid out in the Clearance Certificate issued from Fire Force Department vide No Docket No KSFES/GBC(1)150 Docket No. KSFES/CC/449/2022, dated: 12-09-2022 and CFO from KSPCB vide No AW-332852 PCB ID: 78658 Date: 20-08-2022 and Compliance of submissions made in the affidavits filed to this office
