The Plan was sanctioned for the construction of Residential Building Comprising of Block -1 to 18 Consisting of GF+11UF, Block -19 to 30 Consisting of GF+12UF with Common Basement Floor for Residential Apartment Building and Block -31 to 39 Consisting of BF+GF+1UF for Villas at Property Katha No. 226, Bhoganahalli Village, Sy No. 91/1, 93P, 94/1 & 2P, 95/P, and Doddakannahalli village Sy No. 73/P, 74/P, 92/P, 93/1, 93/2, 94/1A, 94/1B2, 94/1B3, 94/2, 94/3, 94/4P, 96/1A, 1B, 96/2P, 97/P, 98/2P, Marathalli Sub-division, Ward No. 150, Mahadevapura Zone, Bengaluru by this office vide reference (2). And Occupancy Certificate (Partial) issued for Block - 1 to 30 and Villas Building in Block -31 to 39 for 88 Villas on 27-04-2017. Now the Applicant has applied for issue of Occupancy Certificate consisting of Villa Blocks - 31, 32, 34, 37 & 38 Consisting of Part of BF+GF+1UF for 10 Villas. (Villa No.s 508, 511, 514, 517, 528, 541, 542, 548, 581 & 592) KSPCB has issued consent for Operation of Sewage Treatment Plant (STP) Vide Ref (4).

The Villa Buildings in Blocks -31, 32, 34, 37 & 38 was inspected by the Officers of Town Planning Section on 09-12-2020 for the issue of Occupancy Certificate (Partial). During inspection, it is observed that, there is deviation in construction with reference to the Sanctioned plan, which is within the limits of regularization as per Building Bye-laws - 2003. The proposal for the issuance of Occupancy Certificate for the Residential Building in Villas Block - 31, 32, 34, 37 & 38 was approved by the Commissioner vide ref (3). Subsequent to the approval accorded by Commissioner the applicant was endorsed on dated: 03-03-2021 to remit Rs.1,15,67,000/- (Rupees One Crore Fifteen Lakhs Sixty Seven Thousand only) towards Compounding fee for the deviated portion Ground rent arrears, GST, Scrutiny Fees. The applicant has paid of Rs. 1,03,60,001/- (Rupees One Crore Three Lakhs Sixty thousand and One only), as per the Hon'ble High Court Interim order vide W.P. No. 14422/2022 (LB-BMP) dated: 21-07-2022 in the form of DD No. 793436 dated: 07-06-2023 and DD No. 795391 drawn on HDFC Bank and the same has been taken into BBMP account Vide receipt No. RE-ifms 331-TP/000028 dated: 15-06-2023. The deviations effected in the building are condoned and regularized accordingly.

This Occupancy Certificate is issued subject to the following conditions:

1. The car parking at Part of Ground Floors area shall have adequate safety measures. It shall be done entirely at the risk and cost of the owner. BBMP will not be responsible for any kind of damage, losses, risks etc., arising out of the same.
2. The structural safety of building will be entirely at the risk and cost of owner / Architect / Engineer / Structural Engineer and BBMP will not be responsible for structural safety.
3. Owner shall not add or alter materially, the structure or a part of the structure there off without specific permission from BBMP. In the event of the applicant violating, the BBMP has the right to demolish the deviated / altered / additional portion without any prior notice.
4. Part of Ground Floor area should be used for car parking purpose only and the additional area if any available in Part of Ground Floor area shall be used exclusively for car parking purpose only.
5. Footpath and roadside drain in front of the building should be maintained in good condition.
6. Rain water harvesting structure shall be maintained in good condition for storage of water and shall be used for non-potable purpose or recharge of ground water at all times as per Building Bye-laws-2003 clause No. 32 (b).
7. Since, deviations have been done from the sanction plan while constructing the building; the security deposit is here with forfeited.

8. Owner shall make his own arrangements to dispose off the debris/garbage after segregating it into organic and inorganic waste generated from the building. Suitable arrangements shall be made by the owner himself to transport and dump these segregated wastes in consultation with the BBMP Zonal Health Officer.
9. All the rainwater and waste water generated from the usage shall be pumped into the rainwater harvesting pits and used for landscaping.
10. Garbage originating from building shall be segregated into organic and inorganic waste and should be processed Scientifically in the recycling processing unit of suitable capacity i.e. organic waste convertor to be installed at site for its re - use / disposal.
11. This Occupancy Certificate is subject to conditions laid out in the CFO from KSPCB vide No. PCB/287/CNP/09/H 435, dated: 09-08-2017 and Compliance of submissions made in the affidavits filed to this office.
12. The Applicant / Developer should abide by the condition imposed during Occupancy Certificate.
13. All the rain water and waste water generated from the usage shall be pumped into the rain water harvesting pits and used for landscaping.
14. The Demand for payment of fees as per the Interim order of the Hon'ble High Court vide W.P. No. 14422/2022 (LB-BMP) dated:21-07-2022 is subject to condition for remittance of such cost in future, based on the outcome of the final order of the Hon'ble High Court.
15. The Remaining Blocks should be completed as per the Modified Sanctioned Plan & Occupancy Certificate should be obtained after Completion.
16. In case of any false information, misrepresentation of facts, or pending court cases, the Occupancy Certificate shall deemed to be cancelled.

On default of the above conditions the Occupancy Certificate (Partial) issued will be withdrawn without any prior notice.
