



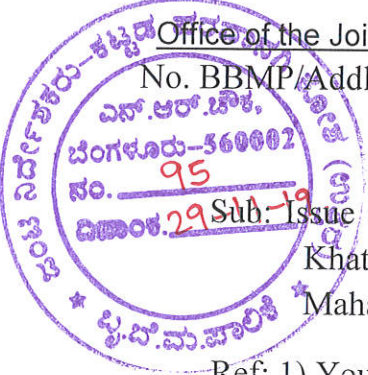

The building plan for the construction of Residential Apartment Buildings at Property Khata No. 117/97/4, Kasavanahalli Village, Varthur Hobli, Ward No. 150, Mahadevapura Zone, Bangalore. Comprising BF+GF+4 UF having 15 Units was sanctioned by this office vide reference (2). The Commencement Certificate was issued on dated: 06-06-2018. Vide Ref (3) KSPCB has issued consent for Operation of Sewage Treatment Plant (STP).

The Residential Apartment building were inspected by the Officers of Town Planning Section on 13-09-2019 for the issue of Occupancy Certificate. During inspection, it is observed that, there is deviation in construction with reference to the sanctioned plan which is within the limits of regularization as per Building Bye-laws - 2003. The proposal for the issuance of Occupancy Certificate for the Residential Apartment building was approved by the Commissioner on date: 15-10-2019. The compounding fee for the deviated portion and Scrutiny fee of Rs.81,500-00 (Rs. Eighty One Thousand Five Hundred Only) has been paid by the applicant in the form of DD No: 000511, drawn on Axis Bank Ltd., dated: 02-11-2019 and taken into BBMP account vide receipt No.RE-ifms 331-TP/000411 dated: 20-11-2019. The deviations effected in the building are condoned and regularized accordingly.

Hence, Permission is hereby granted to occupy the Residential Apartment Building at Property 117/97/4, Kasavanahalli Village, Varthur Hobli, Ward No. 150, Mahadevapura Zone, Bangalore. Comprising BF+GF+4 UF having 15 Units. Occupancy Certificate is accorded with the following details.

1. The car parking at Basement Floor area shall have adequate safety measures. It shall be done entirely at the risk and cost of the owner. BBMP will not be responsible for any kind of damage, losses, risks etc., arising out of the same.
2. The structural safety of building will be entirely at the risk and cost of owner / Architect / Engineer / Structural Engineer and BBMP will not be responsible for structural safety.
3. Owner shall not add or alter materially, the structure or a part of the structure there off without specific permission from BBMP. In the event of the applicant violating, the BBMP has the right to demolish the deviated / altered / additional portion without any prior notice.
4. Basement Floor area should be used for car parking purpose only and the additional area if any available in Basement Floor shall be used exclusively for car parking purpose only.

5. Footpath and road side drain in front of the building should be maintained in good condition.
6. Rain water harvesting structure shall be maintained in good condition for storage of water and shall be used for non potable purpose or recharge of ground water at all times as per Building Bye-laws-2003 clause No. 32 (b).
7. Since, deviations have been done from the sanctioned plan while constructing the building, the security deposit is here with forfeited.
8. Owner shall make his own arrangements to dispose off the debris/garbage after segregating it into organic and inorganic waste generated from the building. Suitable arrangements shall be made by the owner himself to transport and dump these segregated wastes in consultation with the BBMP Zonal Health Officer.
9. All the rain water and waste water generated from the usage shall be pumped into the rain water harvesting pits and used for landscaping.
10. This Occupancy Certificate is issued subject to conditions laid out in the Clearance Certificate issued from CFO issued by KSPCB vide No. W-111787, PCB ID:81959, dated: 14-11-2019 and Compliance of submissions made in the affidavits filed to office.
11. Garbage originating from building shall be segregated into organic and inorganic waste and should be processed Scientifically in the recycling processing unit of suitable capacity i.e. organic waste convertor to be installed at site for its re – use / disposal.
12. In case of any false information, misrepresentation of facts, or pending court cases, the Occupancy Certificate shall deemed to be cancelled.
13. On default of the above conditions the Occupancy Certificate issued will be withdrawn without any prior notice.
