The Commercial Building was inspected on dated: 24-04-2023by the Officers of Town Planning Section for issue of Occupancy Certificate. During inspection, it was observed that, there is deviation in construction with reference to the sanctioned plan which is within the limits of regularization as per Bye-laws. The proposal for the issuance of Occupancy Certificate for the Commercial Building was approved by the Chief Commissioner on dt: 17-05-2023. Payment of Compounding Fees, Scrutiny Fees works out to Rs. 43,81,000/- (Rs. Fourty Three Lakhs Eighty OneThousand only), which has been paid by the applicant vide Receipt No. RE-ifms624-TP/000019 dt: 16-06-2023. The deviations effected in the building are condoned and regularized by imposing penalty. Accordingly, thisOccupancy Certificate is issued.

- The car parking at 2Basement Floors area shall have adequate safety measures. It shall be done entirely at the risk and cost of owner. BBMP will not be responsible for any kind of damage, losses, risks etc., arising out of the same.
- 2. The structural safety of building will be entirely at the risk and cost of owner / Architect / Engineer / Structural Engineer and BBMP will not be responsible for structural safety.
- 3. The owner / applicant shall not add or alter materially, the structure or a part of the structure there off without specific permission of BBMP. In the event of the applicant violating, the BBMP has the right to demolish the deviated / altered / added portion without any prior notice.
- 4. 2Basement Floors area reserved for parking should be used for parking purpose only as per as built plan.
- 5. Footpath in front of the building should be maintained in good condition.
- Rain water harvesting structure shall be maintained in good condition for storage of water for non potable purpose or recharge of ground water at all times as per Building Bye-laws-2003 clause No. 32 (b).
- 7. Since, deviations have been done from the sanctioned plan while constructing the building, the security deposit is herewith forfeited.
- 8. Owner shall make his own arrangements to dispose off the debris/garbage after segregating it into organic and inorganic waste generated from the building. Suitable arrangements shall be made by the owner himself to transport and dump these segregated wastes in consultation with the BBMP SWM Department.
