## CONDITION FOR SERVICES

### 1. Eligibility Criteria :

- The Firm Should be registered in the state Government (Karnataka) organization in current Period for preparation of DPR.
- The interested consultancy firm should have a minimum annual turnover of 180.00 lakhs and in any two financial years from the last five year (2015-16 to 2020-21) duly updating the financial turnover at 10% per annum. The firm should enclose the copy of the Balance sheet duly signed by the Chartered Accountant. Audited Profit and Loss account certified by a practicing Chartered Accountant along with copy of Income Tax returns filed for the years indicated above should be furnished. The consultant should submit the year-wise annual turnover sheet certified by Chartered Accountant  
Note: Turn over statement should include service oriented only
- The interested consultancy firm should have completed DPR for Storm water drain project of similar nature not less than 75.00 crores of the project cost (Similar nature means the work related to SWD in any of metropolitan city of India not less than 500 sq kms). The Consultant should have good experience in the preparation of Design, Estimation in the field of Storm Water / Rainfall and Flood control system & city hydrostatics, disaster management.
- The interested consultant should produce the work completion certificate should be obtained duly signed from an officer not below the rank of Executive Engineer and countersigned by SE/CE as the case maybe.
- If the percentage (amount) quoted by the contractor for the work is below ninety percent of the updated recast estimated amount put to tender, then the contractor shall furnish an additional performance security in the form of FDR for an amount equivalent to the difference between the cost as per quoted percentage (amount) and 90% of the updated re-cast estimated amount put to tender. In case of contractor quoting above 125% of re-cast estimated amount put to tender, then the over and above 125% of the re-cast estimated amount put to tender will be withheld during the progress of work.




- Any effort by the consultant to influence the client in the bid evaluation, bid comparison or contract award decision results in rejection of the consultants bid.

- The firm should have own ISO certification in the field of Preparation of Detailed project report (DPR).
- Consultancy firm should have successfully completed Minimum 3 No's of DPR works in SWD project cost not less than 35.00 crores.
- The firm should have own or tie up with NABL certification in the field of Quality control & quality assurance to test the construction materials as per Morth IRC and other rules and should have other survey and measuring instruments such as Auto Level, Total Station, etc
- Valid GST registration certificate with latest paid challan.
- The bidder should not be black listed or recommended by any department officials.
- Valid Employees Provident Fund Registration Certificate with EPF paid challan for the month previous to the month in which tender is called through e-procurement portal.
- Consultants must establish an office in Bengaluru with necessary infrastructure on award of work.
- Each bidder should furnish liquid assets and or/ availability of credit facilities of 50.00 Lakhs, [Credit lines/ letter of credit/ certificates from banks for meeting the fund requirement etc. (Usually the equivalent of the estimated cash flow for 3 months in the peak construction period)]

As a proof of having visited the site bidders shall upload the certificate issued by the under signed, without which the bids are liable for rejection. ## 2. Qualification information :

- Joint ventures/consortium are not allowed.
- The tender comprises two covering system of (i) Technical Bid and (ii) Financial Bid. The Technical bid containing details of their capability to undertake the tender and scope of service to be carried out, which will be opened first and financial bid contains Bill of quantities (BOQ), which will be opened only if the Consultant is found to be qualified to execute the tendered work. (The intending bidders shall furnish the relevant experience certificates duly signed by the competent authority not less than the rank of Executive Engineer and countersigned by SE/CE as the case maybe.)
