# Qualification of the Tenderer/ Eligibility criteria:

- Any reputed Individual Bruhath Bangalore Company registered with Palike/BWSSB/KUWS&B/PRED/PWD/ Railways/MES/any State or Central Govt., Organisation are eligible to apply
- No Joint Venture / Consortium is permissible.
- GST will be paid to the tendered amount separately only for 2018-19 schedule of rates and for GST/VAT is included in other than 2018-19 schedule of Rates.
- The Tenderer shall have executed and completed successfully in the last five years i.e. between 2016-17 and 2020-21 a single work of similar nature. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority along with Technical Bid.
- The Tenderer should have achieved in at least two financial years a minimum turnover not less than the Two times the amount put to tender.
- Work Completion Certificate for having completed at least one work of similar nature, certified from the Competent Authority not below the Rank of Executive Engineer shall be uploaded. The Work Completion Certific ate shall mention the Nature of Work, Items of Work executed and the Date of Commencement and Date of Completion of the Work.
- 1% of the cost of the bill will be deducted under the building and other construction workers welfare cess act 1996 as per G.O. No. LD/300/LET/2006, Dated: 18.1.2007 and as per Bruhat Bangalore Mahanagara Palike Chief Accounts Officers Circular Vide No. BBMP/CAO/PR/6/07-08, Dated: 03.08.2007.
- The Tenderers shall upload the valid & present Certificate copies of PAN, VAT No., Service Tax Registration No, Contractor's Registration Pass Book for technical bid qualification eligibility.
- The Government authorities taking up construction work shall ensure all the contractors or any sub-contractor hired by the contractor get registration under section 7 of the building and other construction workers' (Regulation of Employment and Condition of Service) Act, 1996. Similarly, all the construction workers shall get registration under section 12 of the Act.

- The work shall be carried out as per the directions of the BBMP and Engineer in-charge.
- Road cut Portion: During the maintenance period if any other agency cut the road for laying BWSSB/OFC/BESCOM & other agency the contractor has to re do the road cut portion. If necessary, permission / payment will be made to the contractor by the other agency through Bruhat Bangalore Mahanagara Palike.
