2. Certified Xerox copy of the valid Registration Certificate issued by BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations and should be enclosed with the tender documents with valid electrical inspectorate license.
3. The Tender Document will form the part and parcel of the Agreement.
4. EMD Declaration should be submitted as in the uploaded format.
5. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
9. The SD amount will be returned after successful completion of ONE year.
10. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason thereof.
11. The Tenderer shall give one year Guarantee for the instruments and maintain for one year and replace such parts, fused out, burnt out and defective parts thereon at free of cost.
12. The contractor belonging to the Scheduled Castes or Scheduled Tribes shall be domicile of the State of Karnataka for more than 10 years. And certified copy of the same (certificate/document) shall be uploaded at the time of Tender.
13. Certified Xerox copies of the documents shall be enclosed along with the Tender, failing which the tender will be rejected.
14. Successful Contractor who is not registered in BBMP shall Register with BBMP before entering in to Agreement for Contract failing which the tender shall be rejected.
15. The Successful Bidder shall have an office within BBMP limits as the maintenance of Electrical installation in BBMP buildings/street light maintenance within the defect and liability period shall be carried out without fail in case of non burning/working of electrical fixtures and repair of Electrical Installation of the respective work. And the Successful Bidder who is residing outside Bengaluru shall submit the details of office existing in BBMP limits before entering into Agreement for Contract failing which the tender shall be rejected.
16. The Income Tax at the rate of 2.00%, SD at 3%, LWC at 1%, CBF at 0.1% and GST as per norms will be Deducted and certificate will be issued in favor of the Contractor from every running bill / final bills of the contractor:
17. Successful tenderer shall note that applicable GST shall be paid along with work bill on tender approved rates of Items whose Estimate rates are based on KPWD (Electrical) SR 2019-20. Extra GST shall not be payable on the Items whose Estimate rates are based on DATA rates or Previous KPWD SR Rates.
18. The work shall be carried out as per the directions of the BBMP Engineer in-charge of work.
19. Black Listed Electrical Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
