The tenderers may submit tenders for works given in the table through e-procurement portal of the Government of Karnataka (viz <http://eproc.karnataka.gov.in>). The Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the instructions to Tenderers to qualify for award of the contract (Standard Tender Document – KW1, KW2, KW3 & KW4)
2. Tenders must be accompanied by Earnest Money Deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 180 days beyond the validity of the Tender.
3. Tenders must be submitted online through e-procurement portal on or before 16.00 hours on 08.01.2021 and the opening of tenders will be as per the e-procurement portal guidelines.

1. Any reputed Individual Company registered with BBMP / CPWD / KPWD / BWSSB / Railways / MES or any State Government Organizations are eligible to apply.
2. Contractors participating for works reserved for SC ST should upload caste certificate issued by competent authority.
3. No Joint Venture Consortium is permissible.
4. The Tender Should be accompanied by the Registration certificate.
5. The Competent authority of the Bruhat Bangalore Mahanagara Palike reserves the right to accept or reject any or all the tenders without assigning any reason thereon.
6. GST will be paid to the tendered amount separately only for 2018-19 schedule of rates and for GST VAT is included in other than 2018-19 schedule of Rates.
7. The Tender will remain valid for 180 Days after the Deadline Date for Tender Submission.
8. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
9. Tenderer who have the works pending with them will not be entertained.
10. The work shall be carried out as per the directions of the BBMP Engineer in-charge.
11. Tender capacity of the Contractor will be based on qualification information vide clause of the Instructions to the Contractors.
12. The defect liability period for completed works is as shown in from the date of final bill.
13. (a) The E.M.D and S.D will be refunded only after Completion of the defect liability period.  
(b) The Total E.M.D and F.S.D amount should be 7.5% of the project cost as applicable.

16. 1% of the cost of the bill will be deducted under the building and other construction workers welfare cess act 1996 as per G.O. No.LD/300/LET/2006, Dated: 18.1.2007 and as per Bruhat Bangalore Mahanagara Palike Chief Accounts Officers Circular Vide No.BBMP/CAO/PR/6/07-08, Dated: 03.08.2007.
17. Road cut Portion: During the maintenance period if any other agency cut the road for laying BWSB/OF/BESCOM & other agency the contractor has to re do the road cut portion. If necessary permission / payment will be made to the contractor by the other agency through Bruhat Bangalore Mahanagara Palike.

### **Eligibility Criteria Follows For Two Cover system**


- i) The Bidder should have executed and completed successfully within the stipulated contract period of similar nature contract not less than 50% of tender amount in last two financial Years. In support of this, bidder should furnish a certificate duly certified by the competent authority along with Technical bid. Achieved in at least two financial years a minimum turnover not less than two times the amount put to tender.
- ii) Present net worth should be two times the amount put to tender. In support of this, bidder should furnish certificate certified by the Chartered Accountant.
- iii) The bidder should quote for all items In all sub works.

### **TECHNICAL BID**

The Technical bid should contain EMD, details of technical, financial & managerial capabilities to execute the work as per the requirements in Para (i) to (iv) above.

### **FINANCIAL BID**

The Financial bid contain only price bid. For such of those contractors, whose technical bids do not satisfy the eligibility, their financial bids will not be opened and the tenders will summarily rejected.
