- 2) Tender documents may be downloaded from Government of Karnataka e-Procurement website <https://eproc.karnataka.gov.in/eportal/index.seam> under login for Contractors. After login to Contractors, scroll down to the left side bottom to see List of Tenders, please click there to find the details of NIT and download copy of the tender. The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit online transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.
- 3) Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC).
- 4) Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal, in the presence of the Tenderers who wish to attend at the Office of the Executive Engineer, Projects-Mahadevapura, 1st Floor, BBMP office, K.R. Pura, Headed by Chief Engineer, Mahadevapura, BBMP to clarify the issue and to answer questions on any matter that may be raised at that stage as stated in "Instructions to Bidders" of the bidding document.
3. Last date for submission of tender documents on or before 29-12-2021 at 17.00 hours
4. Technical Bids will be opened on the website <https://eproc.karnataka.gov.in> in the office of the Executive Engineer, K.R. Pura division on 31-12-2021 at 17.00 hours.
5. Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <https://eproc.karnataka.gov.in>
6. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
7. All the required information required for Bids must be filled and submit online.

Qualification of the Tenderer/ Eligibility criteria:

1. Any reputed Individual / Company registered with Bruhath Bangalore Mahanagara Palike BWSSB/KUWS&B/PRED/PWD/ Railways/MES/any State or Central Govt., Organisation are eligible to apply
2. No Joint Venture / Consortium is permissible.
3. GST will be paid to the tendered amount separately only for 2018-19 schedule of rates and for GST/VAT is included in other than 2018-19 schedule of Rates.
4. The Tenderer shall have executed and completed successfully in the last five years i.e. between 2015-16 and 2019-20 a single work of similar nature. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority along with Technical Bid.
5. The Tenderer should have achieved in at least two financial years a minimum turnover not less than the Two times the amount put to tender.
6. Work Completion Certificate for having completed at least one work of similar nature, certified from the Competent Authority not below the Rank of Executive Engineer shall be uploaded. The Work Completion Certificate shall mention the Nature of Work, Items of Work executed and the Date of Commencement and Date of Completion of the Work.
7. 1% of the cost of the bill will be deducted under the building and other construction workers welfare cess act 1996 as per G.O. No. LD/300/LET/2006, Dated: 18.1.2007 and as per Bruhat Bangalore Mahanagara Palike Chief Accounts Officers Circular Vide No. BBMP/CAO/PR/6/07-08, Dated: 03.08.2007.
8. The Tenderers shall upload the valid & present Certificate copies of PAN, VAT No., Service Tax Registration No, Contractor's Registration Pass Book for technical bid qualification eligibility.
9. The Government authorities taking up construction work shall ensure all the contractors or any sub-contractor hired by the contractor get registration under section 7 of the building and other construction workers' (Regulation of Employment and Condition of Service) Act, 1996. Similarly, all the construction workers shall get registration under section 12 of the Act.
10. If any bidder is quoting the rates less than the tendered amount, the bidder may scan the difference in amount DD & upload the same while submitting the tender.
11. The work shall be carried out as per the directions of the BBMP and Engineer in-charge.
12. Road cut Portion: During the maintenance period if any other agency cut the road for laying BWSSB/OFC/BESCOM & other agency the contractor has to re do the road cut portion. If necessary, permission / payment will be made to the contractor by the other agency through Bruhat Bangalore Mahanagara Palike.
13. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
14. The successful Tenderer shall pay the Difference Cost if any within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.
15. The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office, The Tender Document will form the part and parcel of the Agreement. Failing which the Tender will deem to be get cancelled.
16. The materials shall be got approved by the undersigned before Executing the work.
17. Further Details of the Work can be obtained from the Office of the Executive Engineer, Projects-Mahadevapura, BBMP, Bangalore-36 on all Working Days During office hours.
18. All the participants should produce all the original documents for verification whenever necessary.
19. Certified Xerox copies of the documents shall be enclosed along with the Tender, failing which the tender will be rejected.
20. The Taxes & Cesses will be Deducted as per the governing norms and certificate will be issued in favour of the Contractor from every running bill / final bills of the contractor.
21. The Bruhath Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
22. The Tender will remain valid for 180 Days after the Deadline Date for Tender Submission.
23. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
24. Conditional tenders will not be accepted.
