

5. The accepting authority shall have the power to accept or reject any Bids without assigning any reason thereof.
6. The Bidders blocklisted in Govt/Quasi/Govt/Boards/BBMP etc., are not eligible to participate in this process, subsequently rejected.
7. Conditional Bids will not be accepted.
8. Any Corrigendum/Modification will be notified in the e-procurement portal only.
