- 1. Any reputed Individual / Company registered with I.T, E.S.I, P.F, Labour Department and other statutory authority of Government of Karnataka Organizations are eligible to apply.
- 2. No Joint Venture / Consortium are permissible.
- 3. Tenderer should submit their EMD and tender processing fee in the form of e-payment through e-Procurement Portal (Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC).
- 4. Bidders/Contractors can access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website https://eproc.karnataka.gov.in/.

5. Eligibility Criteria

a. The bidder should have carried out similar services, relating to IT-enabled services (ITES) such as IT-Hardware, IT Software & all Electronic items purchasing services, AMC, Data Entry Manpower Services, IT solutions (Hardware & Software) development & maintenance, IT netServiceing, IT consultancy, IT enable service & E-Governance project services (herein after referred as IT-enabled services) preferably Government/Public sector in last three years, with annual turnover of Rs. 60,00,000/- (Rs.Sixty Lakhs Only) from similar services.

b. Certificate of satisfactory performance for the same has to be furnished.

- c. The bidder should own sufficient data bank of candidates so that continuity of service is maintained and supplied to BBMP
- d. The agency should be registered with I.T, E.S.I, P.F, Labour Department and other statutory authority of Government of Karnataka
- e. Bidder should be enclose previous Service experience certificates of State Government / Public Sector under taking.
- f. Agency should submit their company profile with previous year audit report.
