- Any reputed Individual / Company registered with BBMP/ KPWD /CPWD/Railways/MES / National Highway or any other equivalent central/state govt organizations are eligible to apply.
- Tender documents may be downloaded from Government of Karnataka e-Procurement website <https://kppp.karnataka.gov.in/#/portal/portal-homefrom> under login for Contractors.
- Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <https://kppp.karnataka.gov.in/#/portal/portal-homefrom>.

- Tenderer should submit their EMD and tender processing fee in the form of e-payment through e-Procurement Portal (Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC). In case of reserved works the terms applicable as per govt order No.FD876EXP-12/2017,Bangalore,dated:10/10/2017
- Bidders/Contractors can access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website <https://kppp.karnataka.gov.in/#/portal/portal-homefrom>.
- Corrigendum/ modification/corrections, if any, will be published in the website only. For any clarification on e- Procurement may be contacted HP HELPDESK 080-22485927/22485867.
- The tenders shall be strictly submit as per the formats and terms and conditions specified in the tender documents. Lump sum tenders will not be considered. Separate tenders shall be submitted for each work.
- No Joint Venture / No Consortium are permissible.
- Non submission of the tender attracts action as per conditions stipulated in the rules of registration of Contractors.
- Conditional Tenders will not be accepted.
- Sub-letting of work is prohibited.
- The Tender will remain valid for 180 Days from the Date of Opening of Tender.
- "The rate/amount quoted by the Bidder is less than the rate/amount put to tender, such bidder shall remit the Difference Amount as per the KW1 at the time of work order. Failure to comply with this condition, the tender shall be rejected and EMD amount shall be forfeited".
- In the unlikely event of any dispute pertaining to contractual terms and conditions, terms and conditions specified in standard tender documents (KW-1 to or any other applicable document) of Karnataka government shall prevail and binding.
- The applicant should upload the following documents in e-procurement portal and same copy of original document shall be produce at time of verification.
  - a. Valid electrical inspectorate license
  - b. proof of contract registration certificate.
  - c. Latest Income Tax Certificate & GST Certificate obtained from the concerned Department while submitting the Tender Schedules.
  - d. If the Tenderer/Contractor belongs to category of SC/ST the valid document should be uploaded issued by the GOVT OF Any STATE/CENTRAL for claiming the reserved works

- All applicable state/central statutory tax/fees/deductions imposed by competent authority from time to time shall be deducted from the work bills.
- As per Government order No. LD 300/LET/2006, Dt: 18-07-2007 1% of the bill amount will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
- As per the Standard tender document and also Commissioner order No: CE(TVCC&PPED)PR/18/2012-13 Dated:19/01/2013 the bidder shall remit 3% of Security deposit through such means as prescribed by prevailing rules of government of karnataka, in Favour of Executive Engineer (Ele) Dasarahalli at the time of agreement
- EMD & FSD Amount will be returned after satisfactory completion of one year guarantee period from the date of satisfactory completion of the work.
- The successful bidder should submit Negotiation tenders within 3 days from the date of intimation.
- The successful bidder will have to execute an agreement with BBMP (within 7days from the date of Intimation) failing which his tender is liable to be rejected.
- The work should be commenced with all earnestness within stipulated time from the date of work order failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the tenderer.
- The Contractor has to make own arrangements for procurement of all materials required for the work. There is no departmental supply of materials. Contractor should procure materials with BIS or other relevant standards & obtain necessary quality control certificates from authorized quality control authority. And the same shall be produce at the time of submission of bill.
- As per Government order No. LD 300/LET/2006, Dt: 18-07-2007 the successful contractor shall engage workers registered in "Karnataka State Building & Other Construction Employees Welfare Board." Only
- The successful contractors those not registered in BBMP shall register in BBMP before entering in to Agreement.
- The Bruhat Bangalore Mahanagara Palike reserves the right to accept/reject any or the entire tender's without assigning any reasons.
- The work shall be executed by using quality material, directed by Engineer In charge from time-to-time.
- The sample fittings and other accessories shall got approved from the competent authority.
- The tenderer may obtain further clarifications/information in respect of the tender documents at the office of The Executive Engineer- Electrical, Dasarahalli Zone, Dasarahalli Zone, MEI Layuot Hesaragatta Main Road, Bangalore 560073
- Purchase order and test certificates and quality certificates should be produce before submission of the bill, materials like ABC wires/Cable
- The tendered may obtain further clarifications/information in respect of the tender at this office during office hours
- The new work should be carried out after removal of the existing damaged panel boards/poles/cables/wires etc without any extra cost and as per the direction of the engineer incharge.
- The complete part of the contractors schedule or approved schedule carried out as per the terms and conditions of the contract and engineer incharge. Failure to comply with this the work shall be terminating and fresh tender will inviting.


- Relaxation in qualifying requirement and performance security etc, is admissible to tenderers of reserved category works in accordance with the provisions of KTPP (Amendment) Rules 2017.
- Bidders for the reserved category works shall upload relevant caste certificate and domicile certificate issued by competent authority along with the bid, failing which the tender shall be rejected.
- Bidders to note that, If the rates quoted for any item/items is/are unreasonably varying in comparison with the estimated rates by + (High) / - (less ) 25% ( Twenty five percent ) , then Employer reserves the right to Rationalise entire tender quoted rates in accordance with overall quoted tender premium which shall be binding on the tenderer, failing which the tender shall be rejected.
- The tenderer after becoming successful bidder If elected to withdraw from the tender then, EMD submitted by him for the subject work shall be forfeited and his bid shall be rejected .Further he shall not be eligible to participate in the future tender for the same work.
- The tenderer shall ensure his eligibility to participate in the tender as per specified tender qualification criteria , Submitting tender without possessing minimum required tender qualification as per tender document shall lead to forfeiture of EMD submitted by him for the subject work and his bid shall be rejected .
