ESSENTIAL CONDITIONS:

- 1. The Tender Notification along with Blank Tender Form will be accessible in the website of GOK e-Procurement Platform (http://eproc.karnataka.gov.in) website.
- 2. The interested contractors / suppliers may download the tender documents. The contractors may choose or otherwise attending the pre-bid meeting indicated in the Invitation for Tender.
- Tenders must be accompanied by Earnest Money Deposit Declaration form as specified in the Tender Document as per G.O. No: FD 675 Expenditure -12/2020 Dated: 22-12-2020.
- 4 Tender documents may be downloaded from Government of Karnataka e-Procurement website http://eproc.karnataka.gov.in under login for Contractors. Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website https://eproc.karnataka.gov.in or contact e-Procurement Helpdesk at 080 22485867 / 22485927
- 5 The contractors shall submit the digitally signed tenders electronically on or before the date and time of submission published in the e-procurement portal along with stipulated EMD notified in the tender document.
- The contractor / supplier shall attach scanned DD or Bank Guarantee (for EMD) along with the bid on eprocurement portal and submit the original Bank Guarantee on before the last date and time notified in the Tender Document to the Tender Inviting authority
- The tenders will be evaluated only on confirmation of receipt of payment of EMD
- 8 The Tender will remain valid for 180 Days from the Date of Opening of Tender
- 9 The Contractor is not eligible for submission of application for tender form if he has not put the tender after purchase of the tender document continuously for three times
- 10 The Successful tenderer will have to execute an agreement with BBMP within Seven days of receipt of intimation of Letter of Acceptance, failing which his tender will be summarily rejected without giving any further Notice
- 11 The Contractor / Agency shall intimate the change if any, in any of the addresses email id's phone nos, in advance or maximum within one week of such change along with acknowledgement of noting down of such change in address from the bank. Income tax, GST authorities etc. Failure to do so liability lies on the Contractor / Agency what so ever

- 12. The Work shall be commenced with all Men, Material Tools and Plants within 7 days from the Date of Work Order, failing to which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tendered.
- 13. FSD will be refunded only after **1 Year** from date of completion of DLP & after inspection from competent authority.
- 14. Tenders must be accompanied by Earnest Money Deposit specified for the work in the Table. Earnest Money Deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for **90 days** beyond the validity of the tender.
- 15. As per Govt. Order No: LD 300/LET/2006, Dated: 18.07.2007, 1% of the bill amount will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
- 16. The Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the Instructions to Tenderers to qualify for award of the contract (Standard Tender Document KW-4) also Tenderers are advised to go through the Standard Bid Documents.
- 17. Corrigendum/ modification/corrections, if any, will be published in the website only. For any clarification on e- Procurement or request for e-Procurement training, can be contacted on office of Executive Engineer, Lakes, BBMP, 3rd Floor, Annex Building 03, Head Office Premises, N,R Square, Bangalore-560002 or office phone or E-procurement helpdesk.
- 18. The BBMP reserves the right to accept/reject any or all tenders without assigning any reasons what so ever.
- 19. Successful Tenderer should deliver to the employer a security deposits equivalent 3% of the Contract price in form of DD / Bank Guarantee in favour of Commissioner BBMP otherwise action will be initiated as per Standard Bid document clauses (as per G.O. No: FD 675 Expenditure 12/2020 Dated: 22-12-2020).
- 20 Successful Tenderer if falls under the Reserved Category Security deposit for an amount equivalent as per the revised clause of the contract price shall be deducted in every running bill. However, in case of first and final bill the entire security deposit shall be deducted from the final bill
- 21. An additional security for unbalanced bids (difference amount will be 50% of the unbalanced tender) in the form of DD/ Bank Guarantee to be submitted in favour of Commissioner BBMP otherwise action will be initiated as per Standard Bid document clauses (Including for the reserved category) as per G.O. No: FD 675 Expenditure -12/2020 Dated: 22-12-2020).
- 22. The Tender Accepting Authority shall have the power to accept or to reject any tender without assigning any reason thereof.
- 23. GST shall be paid to the tendered amount separately
- 24. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
- 25. All the participants should produce all the original documents for verification whenever necessary.
- 26. No Joint Venture / Consortium is permissible.

- 27. Conditional Tenders will not be entertained and they are summarily rejected.
- 28 Further particulars can be had from the office of the Executive Engineer-3, Lakes Division, BBMP during the working days between 10.00 A.M. to 5.30 P.M.
- 29. The Construction Debris if any Generated from Work Shall be dumped in Designated Dumping Yards Only.
- 30. If the Contractor has any liability whatsoever to the BBMP / Govt the same will be deducted from the Contractors bills.
- 31. Bidder shall submit the bids electronically before the stipulated date and time for the submission published in e-procurement portal. No tenders can be submitted after the due date and time as the portal will not accept late tenders.
- 32. The contractor / supplier can modify and correct or upload any other relevant document in the portal before last date and time of submission on e-portal. No modifications or withdrawal of tender is possible the closing time of the submission of the tender.
- 33. In the event of the specified date of tender opening being declared a holiday for the tender inviting authority, the tenders will be opened the next immediate working day.
- 34. As per Finance Secretariat Notification No: FD 876 Exp-12/2017, Dated: 15-09-2017, If the Contractor is a firm, then all the partners or members of the form shall belong to the Schedule Caste or Schedule Tribes as the case may be. In this regard the contractor, contract firm should produce the SC/ST Certificate issued by the Competent Authority.
- 35. As per Finance Secretariat Notification No: FD 876 Exp-12/2017, Dated: 15-09-2017, I no qualified tenders belonging to the Schedule Caste or Schedule Tribes participated in the bid in two attempts under the Karnataka Transparency in Public Procurement Rules (Amendment), 2017 then these works will be tendered as open category where in all eligible bidders of General or Schedule Castes or Schedule Tribes.
- 36. The Tenderer shall provide life jackets, gloves, gum boots for the labours whom he is going to employ during the maintenance of the lake.
- 37. The debris removed from the lake shall not be littered & shall be disposed off immediately to the identified/notified places without causing delay.
- 38. The floating debris shall be removed as early as possible in order to avoid spreading of the same and to prevent bad smell keeping in view of the lake users.
- 39 For Labour rates the contractor / Bidder shall not quote below the scheduled rates, If anybody quotes below the scheduled rates the rate analysis for the same shall be prepared duty signed and upload the same in e- Portal, otherwise tender will be rejected
