The Executive Engineer, Mahalakshmiपुरam Division, BBMP, invites tenders on behalf of the commissioner, BBMP, Bengaluru from eligible contractor registered in KPWD registered in KPWD/CPWD/ Railways/ MES/National Highway Or any State Government organizations Class-I Contractor for the work mentioned in the statement below. The bid shall be submitted in Two Cover System containing the technical bid with details mentioned under instructions vide clause-1.1 and financial bid. The blank tender documents can be obtained and submitted through website <http://eproc.karnataka.gov.in>). The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract
2. Tenders 'must be accompanied by Earnest Money Deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.
3. Tenders must be submitted online through e-procurement portal on or before 15.00 hours on **07-05-2021** and the opening of tenders will be as per the e-procurement portal guidelines.



5. To qualify for award of this contract, each Tenderer in his name should have in the last five years financial years (2015-16, 2016-17, 2017-18, 2018-19, 2019-20). (a) Achieved in at least two financial years a minimum financial turnover (in all classes of civil engineering construction works only) usually not less than two times the estimated amount.
6. To qualify for award of this contract, each Tenderer in his name should have in the last five years financial years 2015-16, 2016-17, 2017-18, 2018-19 2019-20) (b) Satisfactorily completed at least one similar work value not less than 50% of the Estimated Amount as prime contractor.

P.F Labour Department , Police department (ISD), GST registration, ISO Certificate (ISO9001:2015, OHSAS 18001:2007 & ISO 50001:2011), Manpower 80 Nos Single workdone, and other statutory authority of Government of Karnataka area eligible to apply for the cleaning and security work.**
