2. No Joint Venture / Consortium is permissible.
3. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period should be enclosed with the tender documents.
4. The Tender Document will form the part and parcel of the Agreement.
5. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
6. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
7. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason there of.
8. The rates quoted in the schedule shall be inclusive of all taxes applicable.

11. The successful Tenderer shall execute an Agreement within 20 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
12. As per Government order no. LD 300/LET/2006, dt: 18/01/2007, 1% of the Estimated Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
13. Each Tenderer should further demonstrate:
14. (a) Availability by owning the following key and critical equipment for this work:
15. (i) For Water Supply Works (Drilling Works) the tenderer shall have minimum two drilling rigs out of which at least one shall be owned by tenderer and other may be on lease. In case of lease, Lease agreement to be executed on Rs. 200/- stamp paper with owners of the rig for a period of two years from the date of this tender notification. Notarized copies of valid rig documents such as RC Book, Fitness certificate upto date tax paid receipt, Insurance paid receipt, and lease agreements should be uploaded.
(ii) One set of GPS Equipment for each rig.
(iii) The tenderer shall have one own RIG Registered with Karnataka Ground Water authority. And shall have to produce **FORM 7'A'** in Original and valid.
16. Sub-Letting of work is prohibited.
17. Frequency of the quality test of all the materials and other tests have to be conducted by the contractor as per MORT&H (IV th Revision) I.R.C. guidelines and other relevant Indian standards in his laboratory or any other laboratory assigned by BBMP on his own cost in presence of Engineer / consultants appointed by BBMP
18. All Works are subject to third party test and the cost of the same shall be borne by the contractor.
