Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal, in the presence of the Tenderers who wish to attend at the OFFICE OF THE EXECUTIVE ENGINEER, K.R.Pura Division, BBMP office, K.R.Pura Bangalore - 560 036. 
TERMS & CONDITIONS:

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium is permissible.
3. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period should be enclosed with the tender documents.
4. The Tender Document will form the part and parcel of the Agreement.
5. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
6. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
7. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason there of.
8. The rates quoted in the schedule shall be inclusive of all taxes applicable.
9. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not Eligible to quote, if found such Tenders will be rejected.
10. The successful Tenderer shall pay the Difference Cost if within 20 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.
11. The successful Tenderer shall execute an Agreement within 20 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
12. As per Government order no. LD 300/LET/2006, dt: 18/01/2007, 1% of the Estimated Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
13. Sub-Letting of work is prohibited.
14. For Water Supply Works Each Tenderer should further demonstrate:
 - (a) Availability by owning the following key and critical equipment for this work:
 - (i) The tenderer shall have minimum two drilling rigs out of which at least one shall be owned by tenderer and other two may be on lease. In case of lease, Lease agreement to be executed on Rs. 200/- stamp paper with owners of the rig for a period of two years from the date of this tender notification. Notarized copies of valid rig documents such as RC Book, Fitness certificate upto date tax paid receipt, Insurance paid receipt, and lease agreements should be uploaded.
 - (ii) One set of GPS Equipment for each rig.
 - (iii) The tenderer shall have one own RIG Registered with Karnataka Ground water authority. And shall have to produce **FORM 7'A'** in Original and valid.
15. Frequency of the quality test of all the materials and other tests have to be conducted by the contractor as per MORT&H (IV th Revision) I.R.C. guidelines and other relevant Indian standards in his laboratory or any other laboratory assigned by BBMP on his own cost in presence of Engineer / consultants appointed by BBMP
16. All Works are subject to third party test and the cost of the same shall be borne by the contractor. Further Details of the Work can be obtained from the Office of the Executive Engineer, K.R.Pura Division, BBMP office, Mahadevpura Bangalore – 560 036 on all Working Days During office hours. All the participants should produce all the original documents for verification whenever necessary.
17. Conditional tenders will not be accepted.
