- Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
- 2. No Joint Venture / Consortium is permissible.
- Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period should be enclosed with the tender documents.
- 4. The Tender Document will form the part and parcel of the Agreement.
