**Eligibility criteria:**

1. No Joint Ventures / Consortiums are permissible.
2. The consulting firm shall have experience of similar nature of work in last Five years i.e. between 2016-17 and 2020-21 of project cost not less than Amount put to tender. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority not less than the rank of Executive Engineer along with Technical Bid.
3. Achieved in at least two financial years a minimum turnover not less than two times the amount put to tender.
4. Present net worth should be two times the amount put to tender. In support of this, bidder should furnish certificate certified by the Chartered Accountant.
5. Latest income tax paid certificate (Challan) from the income tax department.
6. The bids are to be submitted in the electronic tendering system only. The tender comprises single/two cover systems Technical Bid and Financial Bid. The bid containing details of their capability to undertake the tender and scope of service to be carried out, this will be considered.
7. Established office and well equipped NABL Accredited Laboratory.
8. The Bidder should have Established Office in Bangalore and in support of this, the tenderer should furnish the relevant proof of document
9. The tender should list out the manpower, equipments and machineries possessed by him as per the tender documents.
10. Consulting firm should have ISO certification in Quality Management System.
11. Bidder should attach all the scanned copies of certificates pertaining to their eligibility criteria, qualification information documents, failing which the bid will not be considered. No physical documents shall be considered.(also all scanned copies should be visible and should have clarity).
12. For those Tenderers whose Technical Bids do not satisfy the Eligibility Criteria as mentioned above, their Financial Bids will not be opened.
13. Corrigendum / modifications / corrections, if any, will be published in the website/ Notice Board.
14. The successful Tenderer shall enter into the Agreement with the BBMP within 7 days of receipt of intimation. The Tender Document will form the part and parcel of the Agreement.
