The Executive Engineer, Mahalakshmiapuram Division, BBMP, invites tenders on behalf of the commissioner, BBMP, Bengaluru from eligible contractor registered in KPWD registered in KPWD/CPWD/ Railways/ MES/National Highway Or any State Government organizations Class-I Contractor for the work mentioned in the statement below. The bid shall be submitted in Two Cover System containing the technical bid with details mentioned under instructions vide clause-1.1 and financial bid. The blank tender documents can be obtained and submitted through website <http://eproc.karnataka.gov.in>). The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract
2. Tenders 'must be accompanied by Earnest Money Deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.
3. Tenders must be submitted online through e-procurement portal on or before 15.00 hours on **31-12-2020** and the opening of tenders will be as per the e-procurement portal guidelines.

8. Before submission of online bids, bidders must ensure that scanned copies of all the necessary Documents have been attached with bid.
9. All the required information required for Bids must be filled and submit online.

13. Bidder Should fill the BIDDER DECLARATION FORM AND ANNEXURE duly sign, without fail along with all relevant document to be uploaded for the particular work.
14. As per Circular of member secretary, Karnataka ground water authority and director department of mines and geology vide no. DMG/GWD/BDR/23/13-14 dated: 25/04/2013 for bore well drilling works the contractor should submitted form 7(A) rule 8 registration of drilling agency certificate or for bore well drilling works the contractor should submit lease agreement of form 7 (A)

Technical Bid Condition:

1. Eligible contractors registered in KPWD Class-I Contractor (Registration Number date and validity)
2. GST Enrolment Certificate

4. Income tax returns certificate
5. To qualify for award of this contract, each Tenderer in his name should have in the last five years financial years (2015-16, 2016-17, 2017-18, 2018-19, 2019-20). (a) Achieved in at least two financial years a minimum financial turnover (in all classes of civil engineering construction works only) usually not less than two times the estimated amount.
6. To qualify for award of this contract, each Tenderer in his name should have in the last five years financial years 2015-16, 2016-17, 2017-18, 2018-19 2019-20) (b) Satisfactorily completed at least one similar work value not less than 50% of the Estimated Amount as prime contractor.
7. To qualify for award of this contract, each Tenderer in his name should have in the last five years financial years 2015-16, 2016-17, 2017-18, 2018-19, 2019-20). (c) Executed quantities (as per bid document) in any one year for a continuous period of 12 months.
8. Availability by own or lease 50% of the required/specified key and critical equipment for this work and the remaining 50% can be deployed on lease/hire basis for all works provided the relevant documents (commitment agreements etc.) for availability for this work are furnished. 9. Liquid assets and /or availability of credit facilities of not less than 30 % of the estimated amount (Credit lines/ letter of credit/ certificates from banks for meeting the fund requirement etc)
10. Tenderers who meet the above specified minimum qualifying criteria, will only be qualified, if their available tender capacity is more than the total tender value. The available tender capacity will be calculated as under:
Assessed available tender capacity = $(A * N * 1.5 - B)$, where
A = Maximum value of civil engineering works executed in any one year during the last five years (updated to 2017-18 price level) taking into account the completed as well as works in progress.
N = Number of years prescribed for completion of the works for which tenders are invited.
B = Value, at 2017-18 price level, of existing commitments and on-going works to be completed during the next One year.

Note:

1. If any of the dates mentioned above happens to be a general holiday, the next working day holds good.

3. **Conditional tenders are liable to be rejected. The officer competent to accept the tender shall have the right to reject any or all the tenders without assigning any reason whatsoever.**

5. A monthly construction Programme has to be submitted by successful bidder at the time of concluding agreement.
6. If any certificate/information furnished by the bidder is found false, such bid will be treated as non-responsive at the time of Tender Process.
7. The validity period for E.M.D. shall be for a minimum period of 180 days from the date of opening of tenders.
8. The maintenance period or the defect liability period for this work is 36 months from the date of completion of work. The security deposit will be withheld as performance guarantee and will be released after 36 months on proper maintenance.
9. On account of restrictions on sand mining and scarcity of availability of sand, as an alternative the use of manufactured sand (M-sand) may be allowed during the work at no cost/implication.
10. Typographical errors if any will not be ground for any claims by the Bidder.
11. Tendering by Joint ventures/Tie-up will not be allowed.
12. As per proceedings of the Government of Karnataka and Government Order No. LD 300 LET 2006 Bangalore dated 18.01.2007 and Corrigendum dated 28.02.2007, 1% of the amount of cost approved as per the tender notification will be deducted from the bill at the time of payment as cess for the Karnataka State Building & Other Construction Workers Welfare Board.
