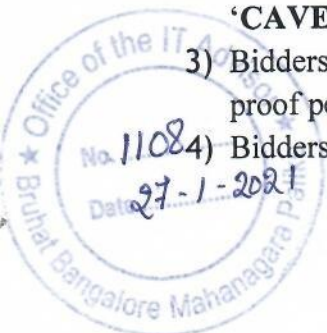

The highest rates received in the E-auction will be considered for acceptance.


The terms and conditions of the E-auction:

- 1) The intending bidders shall pay a tender processing fee as per e-procurement rules through any of the following modes only.
 - a) Credit / Debit Card.
 - b) Net Banking.
 - c) National Electronic Fund Transfer (NEFT)
 - d) Over the Counter (OTC) at ICICI Bank
- 1) Bidders have to access details on the website (<https://eproc.karnataka.gov.in>). Fill and submit the completed E-Auction document into e-procurement on the website itself. Aspiring bidders who have not obtained the User ID and password for participating in E-Auction. Kindly contact e-procurement Help desk on Website.
- 2) The sale of Metal and Wooden Scrap items on the basis of **AS IS WHERE IS** Condition and 'CAVEAT EMPTOR' principle.
- 3) Bidders/contractors shall attach the scanned copies of PAN Card & Aadhar Card for address proof pertaining to their pre-qualification.
- 4) Bidders/contractors shall attach the scanned copy of GST Certificate.



- 5) Bids submitted jointly by more than one person shall not be accepted unless such persons are members of a registered company or Firm and the bid submitted is on behalf of such Company/Firm.
- 6) Bids from persons who are black-listed, convicted, minors, who have failed to pay Government dues or who are insolvent will not be accepted.
- 7) The bidders, shall at the time of submitting the bids, furnish his address and mobile / Land line Number to which all communication could be sent. The Executive Engineer (MPED-Central), BBMP will not be responsible for the consequences (if any) due to communication sent to the address is not received by him. The responsibility to receive all communications shall fully rest with the bidder only.
- 8) The bidders should quote their highest price, exclusive of all statutory a tax for which bid is offered. In addition to payment of the e-auction amount, successful bidders shall also be liable to pay all applicable statutory GST taxes, Cess, fee, levy, etc., the legal charges for conveyance, stamp duty and registration or any other charges as are applicable will have to be borne by the bidder / purchaser.
- 9) The acceptance of the bid will be communicated to the successful bidder as early as possible by post.
- 10) If more than one bidder offers the same rate which is highest for the particular Metal and Wooden scrap item(s), BBMP reserves the right to award the lot after calling for revised open offer from among them.
- 11) The initial bidding for scrap amount starts from Rs.100/-per scrap item (Rupees One hundred) at the increment of Rs.50/-(Fifty Rupees per scrap item).
- 12) The successful bidders shall have to shift the scrap item(s) in respect of which sale are confirmed within 7 (Seven) days of confirmation of sale. Failure to do so, within the said specified period would attract ground rent of Rs.100/-(Rupees One hundred only) per day. In any case, the successful bidders shall shift after confirmation of sale otherwise they are liable to forfeit the amounts paid.
- 13) The successful bidder, as soon as his offer is confirmed and intimated, shall pay a sum equal to 25% of the bid amount after adjustment of Earnest Money Deposit already paid within 7 (Seven) days from the date of confirmation. Thereafter, the balance 75% of the amount shall be paid within 7 (Seven) days from the date of confirmation.
- 14) The amount shall be paid through Demand draft/Bankers Pay in the name of The Commissioner, BBMP. Non-payment of 25% of the bid amount within the stipulated period will result in rejection of the bid and forfeiture of the EMD. Also non-payment of the balance 75% of the bid amount after acceptance of the bid will result in rejection of the bid and forfeiture of 25% of the bid amount deposited, without any notice.
- 15) Bruhat Bangalore Mahanagara Palike (BBMP) reserves the right to re-auction sale and the defaulting bidders, shall have no claim over this.
- 16) Bidders are advised to make themselves conversant with the conditions of the scrap items as well as E-Auction bid before making their offers. No plea of ignorance of any of the conditions will be entertained at a later date. The bidders are advised to seek clarifications or doubts, if any, before submission of their offers.

- 17) The acceptance of bid is subject to confirmation by the competent authority of BBMP, who may confirm or reject all or any bids including the highest bid without assigning any reasons. He reserves the right to alter the conditions of sale or postpone the bid.
- 18) Corrigendum / modification/ correction, if any shall be published in the e-procurement portal only.
- 19) Any dispute arise either with regard to the interpretations of the terms and conditions hereof, the decision of the Commissioner, Bruhat Bangalore Mahanagara Palike (BBMP), shall be final and binding.
- 20) Any other details shall be obtained during office hours.
