Eligibility Criteria:

- 1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
- 2. No Joint Venture / Consortium is permissible.
- 3. Works reserved for SC / ST candidates is strictly prohibited for SC/ST only.
- 4. SC / ST candidates should upload the documents regarding the caste.
- 5. The Tenderr shall upload the Valid and present certificate copies of PAN, GST No, Service Tax Registration No, Contractors Registration pass book, and Caste Certificate for Reserved work for technical bid qualification eligibility.
- 6. The Tenderer shall have executed and completed successfully in the last five years i.e., between 2015-20 to a single work of similar nature of value not less than the estimated value of contract. In support of this, the Tenderer shall furnish a work completion certificate duty certified by the Competent Authority along with Technical Bid.
- 7.. GST Certificate must be enclosed. And Rates should be quoted including GST Charges.
- 8. The Tender shall have achieved in at least two financial years a minimum of turn over not less then the Two times the amount put to tender.
- 9. Work completion certificate for having completed at least one work of similar nature of value not less than the estimated value of contract certified from the competent authority not below the Rank of Executive Engineer shall be uploaded. The work completion certificate shall mention the nature of work, items of work executed and the date of commencement and date of completion of the work.
- 10. If tenderer intends to quote the amount leess the tender amount, such tenderer shall submit the difference amount in the form of DD/Pay order, for the Difference quoted in favour of the Commissioner, BBMP or The Executive Engineer Shanthinagar Division, Payable at Bangalore and the same shall be scanned and uploaded in e portal at the time of Bid submission and the original shall be submitted at the office of Executive Engineer Shanthinagara Division before the opening of the tenders and this will be returned after satisfactory completion of the work and the failure to comply the said conditions, the tender will be rejected.
- 11. The work shall be carried out as per the directions of the BBMP and Engineer-in-charge.
- 12. Black listed contractors/in govt/Quasi govt/boards/BBMP etc., are not eligible to quote, if found such tenders will be rejected.
- 13. The successful Tenderers shall execute an Agreement within 7 days from the date of Receipt of intimation from this office, The Tender Document will form the part and parcel of the agreement, failing which the tender will deem to be get cancelled.
- 14. The material shall be got approved by the undersigned before execute the work.
- 15. Further details of the work can be obtained from the office of the Executive Engineer, Shanthinagar Division, 9th Floor, P.U.Building, M.G. Road, Bangalore –560 001.on all working days during office hours.
- 16. All the participants should produce all the original documents for verification whenever necessary.
- 17. Certified Xerox copies of the documents shall be enclosed along with the tender, failing which the tender will be rejected.
- 18. The Taxes and Cesses will be deducted as per the governing norms and certificate will be issued in favour of the Contractor from very running bill / final bills of the contractor.
