- 2. The Consultant will be selected under Least Cost Selection (LCS) of KC-8 standard bid document.

### 1. Eligibility Criteria:

- a. The Firm Should be registered in any of the Government organization in current Period in PMC/3rd party inspection.
- b. The interested consultancy firm should have completed PMC services for any project of similar nature not less than Cost of the project cost shown in the tabular column above (Similar nature means the Consultant Should have executed Project Storm Water Drain in a single work in any of city of India not less than 100 Lakhs population). The Consultant should have good experience in preparation of design and structural drawing, and providing project management consultancy for Development of Storm Water Drain work in city limit.
- c. The interested consultancy firm should have a minimum annual turnover of Rs.100.00 Lakhs in any two financial years from the (2015-16 to 2019-20) last five years. The firm should enclose the copy of the Balance sheet duly signed by the Chartered Accountant. The vouchers of service (GST) tax paid must be included along with the certificate issued by Chartered Accountant.
- d. The interested consultant should produce the work done certificate should be obtained duly signed from an officer not below the rank of Executive Engineer and countersigned by SE/CE as the case maybe.
- e. Consultant Should have executed or completed successfully any one Project Management Consultancy Service including Proof Checking of Designs and Drawings, Construction Management, Quality Assurance in Storm Water Drain in a single work in any of city of India not less than 100 Lakhs population & Project Cost should not be less than Rs. 700.00 Lakh in any of the Financial Year (from 2015 16 to 2019 20)
- f. The firm should have completed DPR (Survey, Planning, Designing and Estimates) services for similar nature work not less than cost 700 Lakhs.
- g. Consultants must should have an established office in Bangalore with necessary infrastructure.
- h. Joint ventures/consortium are not allowed
- i. The consultant should have experience In Minimum of Three Similar (Storm Water Drain) PMC projects under ULB for Project costing minimum Rs. 5.00 Crores.
- j. The firm should have own ISO certification in the field of Preparation of Detailed project report (DPR) and PMC works
- k. Consultant should have approved own laboratory in his own name. Memorandum of understanding with another laboratory for NABL Accreditation is Accepted in Bangalore..... to test the construction materials as per Morth IRC and other rules n should have other survey and Measuring instruments Like Auto Level, Total Station. Etc
- 1. Latest copy of the Income Tax return for financial year 2019-20 (Assessment year 2019-20).

- m. Valid GST registration certificate with latest paid challan.
- n. The bidder should not be black listed or recommended by any department officials
- o. Valid Employees Provident Fund Registration Certificate with EPF paid challan for the month previous to the month in which tender is called through e-procurement portal.

#### 2. Essential Conditions

- 1) The BBMP reserves the right to accept/reject any or all tenders without assigning any reasons what so ever.
- 2) The Tender Accepting Authority shall have the power to accept or to reject any tender without assigning any reason thereof.
- 3) The Income Tax, Service Tax and any Other Taxes Applicable from time to time will be deducted and certificate will be issued in favor of the Consultants from every running bill / final bills.
- 4) NSIC/MSME Certificates will not be considered For EMD.
- 5) The rates quoted shall be inclusive of all taxes as applicable, including GST.
- 6) Black Listed Consultants / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
- 7) All the participants should produce all the original documents for verification whenever necessary.
- 8) The work shall be carried out as per the directions of the BBMP and if necessary in coordination with BESCOM, BWSSB, Other Agencies and Engineer in charge of Work.
- 9) Conditional proposals will not be entertained and they are summarily rejected.
- 10) The Consultants should undertake to follow Labour Laws on, rules notification or any such Govt. Orders/BBMP orders which are in force or which may be come into effect at any time of execution of contract. And also he/she should abide by the Commissioner's Office order no:B12(C1)/PR/20/2014-15. ## Brief Scope of Work: The Scope of Work Includes the

## Following,

- 11) The Tender will remain valid for 180 Days from the Date of Opening of Tender.
- 12) The Consultant / Agency shall intimate the change, if any, in any of the addresses, in advance or maximum within one week of such change along with acknowledgement of noting down of such change in address from the bank, Income tax, Sales Tax authorities etc. Failure to do so liability lies on the Consultant / Agency what so ever.
- 13) The Work shall be commenced with all Men, Material Tools and Plants within 7 days from the Date of Work Order, failing to which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
- 14) Supervision of Work on Day to Day Basis and Submission of Report to Concerned AE, AEE & EE.
- 15) Project Management Consultancy Preparation of Providing PERT/ CPM Chart etc.
- 16) Uploading Day to Day Progress and GPS Map Photographs of work to BBMP Web Site.

17) Frequency of the Quality tests of all the materials and other tests have to be conducted as per Specifications for Road and Bridge Works (5th Revision), IRC:SP:11-1984 Handbook of Quality Control Construction of Roads and Runways, IRC:SP:47- 1998 Guidelines on Quality Systems for Road Bridges (Plain, Reinforced, Prestressed), RC:SP:57-2000 Guidelines for Quality Systems for Road Construction and Composite Concrete and SP:7-2005 National Building Code of India, SP:63 2007 Explanatory Guide for the application of Quality System Standards (IS ISO 9001, 9002 & 9003), IS: 456-2000, Plain and Reinforced Concrete-Code of Practice (Fourth Revision), IS: 800-2007, Code of Practice for General Construction in Steel: Code of Practice 3rd Revision, Indian Building Congress: Quality Manual for Civil works in Building Projects & other relevant Indian standards in his laboratory in presence of Engineer in Charge and respective Contractors.

### 3. Qualification information:

The Technical bid containing details of their capability to undertake the tender and scope of service to be carried out, which will be opened first and financial bid, which will be opened only if the Consultant is found to be qualified to execute the tendered work. (The intending bidders shall furnish the relevant experience certificates duly signed by the competent authority not less than the rank of Executive Engineer and countersigned by SE/CE as the case maybe.)

Consultants should attach all the Scanned copies of certificates pertaining to their eligibility criteria, qualification information documents, failing which the bid will not be considered. No physical documents shall be considered.

7. For those Tenderers whose Technical Bids do not satisfy the Eligibility Criteria as mentioned above, their Financial Bids will not be opened.

8. Latest income tax paid certificate (Challan) from the income tax department.

Any effort by the consultant to influence the client in the bid evaluation, bid comparison or contract award decision results in rejection of the consultants bid. 10. A successful tenderer will have to execute an agreement with Executive Engineer, (Dasarahalli Zone-SWD), BBMP within 7 days upon receipt of intimation. The work shall be commenced with all earnestness within seven days from the date of issue of work order, failing which it would be presumed that he is not interested in the work and action will be taken to cancel the tender at the risk and cost of agency.
