The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderer's to qualify for award of the contract (Standard Tender Document -KW1, KW2, KW3 & KW4).

- 3. Tenders must be accompanied by earnest money deposit which shall be paid online through e-Procurement portal.

#### Eligibility criteria:

- 1. No Joint Ventures / Consortiums are permissible.
- 2. The Tenderer shall have experience of similar nature of work in last Five years i.e. between 2016-17 and 2020-21 of project cost not less than 50 % of Amount put to tender. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority not less than the rank of Executive Engineer along with Technical Bid.
- 3. Achieved in at least two financial years a minimum turnover not less than two times (only civil works) the amount put to tender. Duly certified by Charted Account.
- 4. Present net worth should be two times the amount put to tender. In support of this, bidder should furnish certificate certified by the Charted Accountant.
- 5. Latest income tax paid certificate (Challan) from the income tax department.
- 6. The bids are to be submitted in the electronic tendering system only. The tender comprises single/two cover systems Technical Bid and Financial Bid. The bid containing details of their capability to undertake the tender and scope of service to be carried out, this will be considered.
- 7. The Bidder should furnish the list of manpower, equipments and machineries possessed by him as per the tender documents.
- 8. Bidder should attach all the scanned copies of certificates pertaining to their eligibility criteria, qualification information documents, failing which the bid will not be considered. No physical documents shall be considered.(also all scanned copies should be visible and should have clarity).
- 9. Procurement of works use of standard tender documents Revision Go No. FD/480/Exp-12/2014 Dated: 19-07-2014 and Go No. FD 876/Exp 12/2017 Bangalore Dated: 10-10-2017 will be applicable who belongs to Scheduled Castes and Scheduled Tribe Category.
- 10. As per the Government Order No.(CAO/Budget:647/209-10 Date:24.05.2010) Deduction of Royalty form the bills of the Contractors working in Civil works, if the Contractor proves that aspect of the matter then the Department/ work executing agency cannot recover or deduct any royalty from the bills of the contractor, if the documents/ MDP's are produced from the quarry lease holders or Private quarry owners in this regard then the contractor is not liable to pay the royalty charges.
- 11. For those Tenderers whose Technical Bids do not satisfy the Eligibility Criteria as mentioned above, their Financial Bids will not be opened.
- 12. Corrigendum / modifications / corrections, if any, will be published in the website only.

13. The successful Tenderer shall enter into the Agreement with the BBMP within 7 days of receipt of intimation. The Tender Document will form the part and parcel of the Agreement.

14. The Bruhat Bangalore Mahanagara Palike reserves the right to accept /

reject any or all the Tenders without assigning any reasons.

15. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.

The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
