The Work Completion Certificate shall mention the Nature of Work, the Date of Commencement and Date of Completion of the work.
- The bidder shall have achieved at least two financial years a minimum financial turnover not less than the estimated annual payment under this contract in all civil Engineering works in last 5 years. The bidder shall submit balance sheets as proof of having annual turn over as above, which shall be duly certified by a Chartered Accountant.
