Pura, Headed by Executive Engineer(P), Mahadevapura, BBMP to clarify the issue and to answer questions on any matter that may be raised at that stage as stated in "Instructions to Bidders" of the bidding document.
- 3. Last date for submission of tender documents on or before 14-10-2024 at 17.00 hours
- 4. Technical Bids will be opened on the website <u>KPPP Portal (karnataka.gov.in)</u> in the office of the Executive Engineer (Project) BBMP, Mahadevapura Zone on 15-10-2024 at 17.00 hours.
- 5. Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website KPPP Portal (karnataka.gov.in)
- 6. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
- 7. All the required information required for Bids must be filled and submit online.

Qualification of the Tenderer/ Eligibility criteria:

- 1. Any reputed Individual / Company registered with Bruhat Bangalore Mahanagara Palike/BWSSB/KUWS&B/PRED/PWD/ Railways/MES/any State or Central Govt., Organization are eligible to apply.
- 2. No Joint Venture / Consortium is permissible.
- 3. GST will be paid to the tendered amount separately only for 2023-24 schedule of rates and for GST/VAT is included in other than 2023-24 schedules of Rates.
- 4. The Tenderer shall have executed and completed successfully in the last five years i.e. between 2018-19 and 2023-24 a single work of similar nature. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority along with Technical Bid.
- 5. The Tenderer should have achieved in at least two financial years a minimum turnover not less than the Two times the amount put to tender.
- 6. Work Completion Certificate for having completed at least one work of similar nature, certified from the Competent Authority not below the Rank of Executive Engineer shall

- be uploaded. The Work Completion Certify ate shall mention the Nature of Work, Items of Work executed and the Date of Commencement and Date of Completion of the Work.
- 7. 1% of the cost of the bill will be deducted under the building and other construction workers welfare cess act 1996 as per G.O. No. LD/300/LET/2006, Dated: 18.1.2007 and as per Bruhat Bangalore Mahanagara Palike Chief Accounts Officers Circular Vide No. BBMP/CAO/PR/6/07-08, Dated: 03.08.2007.
- 8. The Tenderer shall upload the valid & present Certificate copies of PAN, VAT No., Service Tax Registration No,

Contractor's Registration Pass Book for technical bid qualification eligibility.

- 9. The Government authorities taking up construction work shall ensure all the contractors or any sub-contractor hired by the contractor get registration under section 7 of the building and other construction workers' (Regulation of Employment and Condition of Service) Act, 1996. Similarly, all the construction workers shall get registration under section 12 of the Act.
- 10. If any bidder is quoting the rates less then the tendered amount, the bidder may scan the difference in amount DD & upload the same while submitting the tender.
- 11. The work shall be carried out as per the directions of the BBMP and Engineer incharge.
- 12. Road cut Portion: During the maintenance period if any other agency cut the road for laying BWSSB/OFC/BESCOM & other agency the contractor has to re do the road cut portion. If necessary, permission / payment will be made to the contractor by the other agency through Bruhat Bangalore Mahanagara Palike.
- 13. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
- 14. The successful Tenderer shall pay the Difference Cost if any within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.
- 15. The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office, The Tender Document will form the part and parcel of the Agreement. Failing which the Tender will deem to be get cancelled.
- 16. The materials shall be got approved by the undersigned before Executing the work.
- 17. Further Details of the Work can be obtained from the Office of the Executive Engineer, Projects-Mahadevapura, BBMP, and Bangalore-36 on all Working Days During office hours.
- 18. All the participants should produce all the original documents for verification whenever necessary.
- 19. Certified Xerox copies of the documents shall be enclosed along with the Tender, failing which the tender will be rejected.
- 20. The Taxes & Cesses will be Deducted as per the governing norms and certificate will be issued in favour of the Contractor from every running bill / final bills of the contractor:

The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
- 24. Conditional tenders will not be accepted.
