Executive Engineer (Elect), West Zone, invites Item Rate Tenders in accordance with KTPP rules 2000 and 2017, from eligible contractors registered in Bruhat Bengaluru Mahanagara Palike /KPWD/CPWD/Railways/MES/National Highway or any other equivalent central/state government organisations on behalf of the commissioner, BBMP, for the work of **O** & **M** of Street lighting system in West Zone, BBMP as detailed in the table. The bidders may submit their bids for works given in the table below through E-Procurement portal of the Government of Karnataka (viz <a href="https://www.kppp.karnataka.gov.in">https://www.kppp.karnataka.gov.in</a>.) The bidders are advised to note the minimum qualification criteria specified in clause-3 of the ITT(KW-1, KW-2, KW-3, KW-4) to qualify for award of the contract.

### **Tender Terms & Conditions.**

- 1. Qualifying requirements: The Tenderer shall have a **Valid Electrical Inspectorate License** and also to be a registered electrical contractor of Appropriate class with
  Bruhat Bengaluru Mahanagara Palike/KPWD/CPWD/Railways/MES/National
  Highway or any other equivalent central/State Government Organisations. A copy of
  the valid electrical license shall be uploaded.
- 2. The Tenderer shall furnish documents like work completion certificate duly certified by the Competent Authority not below the Rank of Executive Engineer, turnover certificate issued by Charted Accountant with minimum of turnover not less than the amount put to tender for two years between **2019-20 to 2023-24** as per the Bid document KW 1 and KW 2 in accordance with prevailing rules.
- 3. The work completion Certificate shall specify the nature of work, items and quantity of work executed and the date of completion of work as detailed in Tender Documents.
- 4. The Tenderer shall upload the valid and present Certificate copies of PAN & GST NO.
- 5. The tenders will be opened on the due date and time of opening as indicated in the tender document.
- 6. It is stipulated that, if "The rate/amount quoted by the Bidder is less than the rate/amount of the amount put to tender, such bidder shall remit 100% of the Difference Amount through such means as prescribed by prevailing rules of government of karnataka, in favour of Executive Engineer (Elec) West zone at the time of Agreement. This Difference Amount will be returned after Satisfactory completion of the work without Interest. Failure to comply with this condition, the tender shall be rejected".
- 7. It is Stipulated that, For any Specialized work or other works to be specified or as per prevailing rules, intending tenderer shall have required work qualification of "Executing similar nature of single work of 50% of Estimate value of this work, involving execution of specified items of work as per Schedule-B" and as proof tenderer shall upload work done certificate issued by officer not below the rank of Executive Engineer in accordance with financial limits of tenders.
- 8. As per the Standard tender document and also Commissioner order No: CE(TVCC&PPED)PR/18/2012-13 Dated:19/01/2013 the bidder shall remit 3% of

Security deposit through such means as prescribed by prevailing rules of Government of Karnataka, in Favor of Executive Engineer (Ele) West at the time of

agreement.

9. The tenderer may obtain further clarifications/information in respect of the tender documents at the Office of the Executive Engineer (Ele), West Zone, Brunt Bengaluru Mahanagara Palike, No. 98, 8th Cross, Malleshwaram, Bengaluru-560003

10. The tender accepting authority shall have the power to accept or reject any tender

without assigning any reason thereof.

11. While carrying out electrical works the tenderer shall carry out the works through qualified personnel & in consultation with BESCOM for line clearance etc. In the event of any mishap or accident tenderer is held solely responsible and shall indemnify BBMP in this regard.

12. The Fittings & other accessories proposed to be used in the work shall be got approved by the competent authorities before taking up the work. The indicated

quantities are subject to variation as per prevailing rules.

13. Tenderer should posses/own required tools, Equipment, special vehicles as specified in tender document in his/his firm name and shall submit copies of appropriate documents submit original document along with agreement failing which the tender shall be rejected.

14. The contractors shall produce original, registration pass book at the time of

agreement & the entries will be made in such pass book.

- 15. The contractors black listed in Govt/Quasi/Govt/Boards/BBMP etc., are not eligible to participate in this tender, if any the tenders of such tenderer shall be rejected.
- 16. No Joint Venture/Consortium is permissible.
- 17. Conditional Tenders will not be accepted.
- 18. The Contractor has to make own arrangements for procurement of all materials required for the work. There is no departmental supply of materials. Contractor should procure materials with BIS or other relevant standards & obtain necessary quality control certificates from authorized quality control authority.

19. Sub-letting of work is prohibited.

20. Any Corrigendum/Modification will be notified in the e procurement portal.

21.As per Government order No. LD 300/LET/2006, Dt: 18-07-2007 1% of the bill amount will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.

22. Necessary Taxes and other deductions shall be deducted from contractors Bills.

23. The successful bidder has to execute an agreement with BBMP within Stipulated

period, failing which his tender shall be rejected.

- 24. The work shall be commenced with all earnestness as notified, failing which, it shall be presumed that the tenderer is not interested in the work and action shall be taken to get the work executed through alternate agency at the risk and cost of the tender.
- 25. The BBMP reserves the right to accept/reject any or the entire tenders without assigning any reasons.

**a.** BBMP reserves the right to reduce or extend by maintenance period or everyone stop the work itself.

**b.** Any other details regarding the works & other information can be obtained from the above office during office hours

26. Not with standing anything contained herein, prevailing rules of GOK and clauses of appropriate standard tender documents shall also applicable along with conditions specified herein.

27. The Tender of successful bidder shall be rejected if,

a. Made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements: and/or

- **b.** Record of poor performance such as abandoning the works, not properly completing the Contract, inordinate delays in completion, litigation history, or financial failure etc:and/or
- **c.** Participated in the previous tender for the same work and had quoted Unreasonably high / low Tender prices and could not furnish rational justification.
- 28. The tenderers shall note that, In Labour / Manpower oriented Items of any of the above tender, If "The rate quotes by the tenderer is less than stipulated schedule rates, such tenders shall be rejected."
- 29. The Successful Tender shall obtain approval From BESCOM / KPTCL / CEIG as necessary for arranging Electrical power supply. However necessary deposit amount shall be paid by the department.
- 30. Successful tenderer shall note that applicable GST shall be paid along with work bill on tender approved rates of Items whose Estimate rates are based on KPWD (COMMON SR 2023-24. Extra GST shall not be payable on the Items whose Estimate rates are based on DATA rates or Previous KPWD SR Rates.
- 31. Relaxation in qualifying requirement and performance security etc, is admissible to tenderers of reserved category works in accordence with the provisions of KTPP (Amendment) Rules 2017.
- 32. Bidders to note that, If the rates quoted for any item/items is/are unreasonably varying in comparission with the estimated rates by + (High) / (less ) 25% ( Twenty five percent ), then Employer reserves the right to Rationalise entire tender quoted rates in accordence with overall quoted tender premium which shall be binding on the tenderer, failing which the tender shall be rejected.
- 33. The tenderer after becoming successful bidder if elected to withdraw from the tender then, EMD submitted by him for the subject work shall be forfeited and his bid shall be rejected. Further he shall not be eligible to participate in the future tender for the same work.
- 34. The tenderer shall ensure his eligibility to participate in the tender as per specified tender qualification criteria. Submitting tender without possessing minimum required tender qualification as per tender document shall lead to forfeiture of EMD submitted by him for the subject work and his bid shall be rejected.
