Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. 1. Geo Tagged Photos and Videos Should be given.
2. For Water Supply Works Each Tenderer should further demonstrate:
 - (a) Availability by owning the following key and critical equipment for this work:
 - (i) The tenderer shall have minimum two drilling rigs out of which at least one shall be owned by tenderer and other two may be on lease. In case of lease, Lease agreement to be executed on Rs. 200/- stamp paper with owners of the rig for a period of two years from the date of this tender notification. Notarized copies of valid rig documents such as RC Book, Fitness certificate upto date tax paid receipt, Insurance paid receipt, and lease agreements should be uploaded.

- (ii) One set of GPS Equipment for each rig.
 (iii) The tenderer shall have one own RIG Registered with Karnataka Ground water authority. And shall have to produce valid **FORM 7A'** in Original/Agreement of **FORM 7A**.
3. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
 4. No Joint Venture / Consortium is not permissible.
 5. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period of 2020-2025 should be enclosed with the tender documents.
 6. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
 7. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
 8. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
 9. Tenderer who have the works pending with them will not be entertained. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason thereof.
 10. The Income Tax at the rate of 2.30%, GST as applicable and Cess at 1% will be Deducted and certificate will be issued in favor of the Contractor from every running bill / final bills of the contractor: Upload the GST Registration Certificate
 11. The rates quoted in the schedule shall be inclusive of all taxes applicable.
 12. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
 13. The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
 14. As per Government order no. LD 300/LET/2006, dt: 18/01/2007, 1% of the Estimated Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
 15. Sub-Letting of work is prohibited.
 16. The defect liability period for civil works & Asphalt works period is three year from the date of final bill. The Performance security amount will be refunded only after the defect liability period.
 17. Tenderers can submit the tenders for all the works. However this is subject to fulfillment of tender capacity condition and all as per standard tender document for procurement of works KW-2,3 & 4.
 18. Frequency of the quality test of all the materials and other tests have to be conducted by the contractor as per MORT&H (IV th Revision) I.R.C. guidelines and other relevant Indian standards in his laboratory or any other laboratory assigned by BBMP on his own cost in presence of Engineer / consultants appointed by BBMP Further Details of the Work can be obtained from the Office of the Executive Engineer, Mahadevpura Division, BBMP office, Mahadevpura Bangalore - 560 048 on all Working Days During office hours.
