
1. No Joint Ventures / Consortiums are permissible.

3. Consultants should have achieved a minimum annual Financial Turnover (in all classes of Civil Engineering Consultation Works only) as per tender document from 2016-17 and 2020-21.
4. Consultants should have completed preparation of Detailed Project Report for roads and drains length as per tender document in last five Years (2016-17 and 2020-21)
5. Adequacy of the Proposed Work Plan and Methodology in response to the TOR - Site appreciation, Project Time Scheduling.
6. Established office in Bengaluru and well equipped own NABL Laboratory or own Laboratory with MOU from NABL Accredited Laboratory. Consultant should submit proof of pertaining documents of laboratory.
