- 11. Black Listed Contractors / in Govt./ Quasi Govt./ Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
- 12. The successful Tenderer shall execute an Agreement within **20 days from** the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
- 13. As per Government order no. LD 300/LET/2006, dt: 18/01/2007, 1% of the Estimated Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
