1. The Tender Notification along with Blank Tender Form will be accessible in the website of GOK e-Procurement Platform (<http://eproc.karnataka.gov.in>) website.

2. Tender documents may be downloaded from Government of Karnataka e-Procurement website <http://eproc.karnataka.gov.in> under login for Contractors. Aspiring Bidders / Contractors who have not registered in e-procurement should register before participating through the website <https://eproc.karnataka.gov.in> or contact e-Procurement Helpdesk at 080 – 25501216 / 25501227
3. The Tender will remain valid for **180 Days** from the Date of Opening of Tender.
4. The Contractor is not eligible for submission of application for tender form if he has not put the tender after purchase of the tender document continuously for three times.
5. The Successful tenderer will have to execute an agreement with BBMP within seven days of receipt of intimation of Letter of Acceptance, failing which his tender will be summarily rejected without giving any further Notice.
6. The Contractor / Agency shall intimate the change, if any, in any of the addresses, in advance or maximum within one week of such change along with acknowledgement of noting down of such change in address from the bank, Income tax, Sales Tax authorities etc. Failure to do so liability lies on the Contractor / Agency what so ever.
7. The Work shall be commenced with all Men, Material Tools and Plants within 7 days from the Date of Work Order, failing to which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tendered.
8. As per the Commissioner Order No:C(PR)/E-9251/20-21, Dt:30.01.2021, The contractor should upload the EMD declaration form with Attested Notary copy.
9. Necessary taxes and other deductions will be made from Contractor bills.
10. Frequency of the Quality tests of all the materials and other tests have to be conducted by contractor as per Specifications for Road and Bridge Works (5th Revision) and IRC:SP:11-1984 Handbook of Quality Control for Construction of Roads and Runways, IRC:SP:47-1998 Guidelines on Quality Systems for Road Bridges (Plain, Reinforced, Prestressed), RC:SP:57-2000 Guidelines for Quality Systems for Road Construction and Composite Concrete and SP:7-2005 National Building Code of India, SP:63 2007 Explanatory Guide for the application of Quality System Standards (IS ISO 9001, 9002 & 9003), IS: 456-2000, Plain and Reinforced Concrete-Code of Practice (Fourth Revision), IS: 800-2007, Code of Practice for General Construction in Steel: Code of Practice 3rd Revision, Indian Building Congress: Quality Manual for Civil works in Building Projects. & other relevant Indian standards in his laboratory or any other Laboratory assigned by the BBMP on his own cost in presence of Engineer/ consultants appointed by BBMP.
11. As per Govt. Order No: LD 300/LET/2006, Dated: 18.07.2007, 1% of the bill amount will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
12. The Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the Instructions to Tenderers to qualify for award of the contract (Standard Tender Document – KW-4) also Tenderers are advised to go through the Standard Bid Documents.
13. Any Corrigendum / Modification will be notified in the Notice Board of the Undersigned.
14. The BBMP reserves the right to accept/reject any or all tenders without assigning any reasons what so ever.

15. The Tender Accepting Authority shall have the power to accept or to reject any tender without assigning any reason thereof.
16. **Applicable statutory deduction as per section 51 deducted in the concerned contractor bills, GST will be borne by the Employee.**
17. As per Proceedings of Director, Mines and geology Dated:25.03.2013 the contractor is mandatory to submit mineral despatch permits from authorised Mines, Otherwise five times the Royalty will be deducted from the contractor bills as per prevailing notification.
18. As per Government Circular No. CI 226 MMN 2006 Dt: 04.12.07 the contractors are liable to pay royalty in terms of the contract if they are not able to produce the materials purchased document / MDP's from where they purchase.
19. The maintenance of period in case of Chip Carpeting & Asphaltting works for more than 40mm thick bituminous layer and less than 40mm thick bituminous layer defect liability period is **3 Years & 2 Years respectively** and **1 Year** for civil works from the date of final bill / or after the expiry of maintenance period whichever is later.
20. For Asphaltting works, like Pothole filling, Chip Carpeting, B.M & B.C etc., those who own their hot mix plant & mechanical paver only need apply. Such of those tenderer will have to furnish the list of machinery equipment along with the copy of the Registration Certificate at the time of scanning of tender documents.
21. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
22. All the participants should produce all the original documents for verification whenever necessary.
23. The work shall be carried out as per the directions of the BBMP and if necessary in coordination with BESCOM, BWSSB, Other Agencies and Engineer in charge of Work.
24. No Joint Venture / Consortium is permissible.
25. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderers.
26. Tender difference Amount should be scanned and up-loaded for all individual works quoted separately to e-Procurement Plat form in form of DD / FDR/TDR /Bank Guarantee and original should be submitted to this office before final date and time mentioned in the Tender notification.
Note: Combined DD / FDR/TDR /Bank Guarantee scanned & submitted are not accepted and liable for rejection
27. Within 7 days of receipt of the Letter of Acceptance, the successful Tenderer shall deliver to the Employer a Security Deposit of Tendered Amount in form of DD /Bank Guarantee drawn in favour of Commissioner, BBMP A/c Executive Engineer, Malleshwaram Division, BBMP, Bangalore payable at Bangalore from nationalized / scheduled bank for an amount equivalent to 3% of the Contract price. Otherwise Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderers.
28. Conditional Tenders will not be entertained and they are summarily rejected.
29. Further particulars can be had from the office of the Executive Engineer, Malleshwaram Division, and BBMP during the working days between 10.00 A.M. to 5.30 P.M.
30. The Construction Debris Generated from Work Shall is dumped in Designated Dumping Yards Only.
31. The bidders/Contractors should undertake to follow Labour Laws on, rules notification or any such Govt. Orders/BBMP orders which are in force or which may be come into effect at any time of

execution of contract. And also he/she should abide by the Commissioner's Office order no:B12(C1)/PR/20/2014-15 Dt: 08.08.2014.

32. Hot Mix Plant should be within radius of 40 Km from execution of work with location tagged in Google Map mandatory
33. Special conditions of contract if any and modification if any will be displayed in office notice board by the under signed and a copy will be uploaded to e-portal from time to time
34. As per the Commissioner Order No:C(PR)/5054/17-18, Dt:02.11.2017 The contractor belonging to SC/ST shall be domicile of the State of Karnataka more than 10-years.
35. The Tenderers shall upload the valid & present Certificate copies of PAN, CGST / SGST., Service Tax Registration Number, Contractor's Registration Pass Book for technical bid qualification eligibility.
