The tenderers may submit tenders for works given in the table through e-procurement portal of the Government of Karnataka (viz., https://eproc.karnataka.gov.in). The Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
- 2. Tender documents may be downloaded from the e-procurement portal of the Government of Karnataka.
- 3. Tenders must be accompanied by Earnest Money Deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.
- 4. Tenders must be submitted online through e-procurement portal on or before 16.00 hours on 25.07.2022 and the opening of tenders will be as per the e-procurement portal guidelines.

# Eligibility Criteria:

- 1. The Tenderer shall have executed and completed successfully a single similar nature of work of value not less than 50% value of amount put to tender in any one financial year during block period of previous five financial years. i.e. between 2017-18 and 2021-22. In support of this, the Tenderer shall furnish a between Completion Certificate duly certified by the competent Authority not below Work Completion Certificate duly certified by uploaded along with Technical Bid. The the Rank of Executive Engineer shall be uploaded along with Technical Bid. The Work Completion Certificate shall mention the Nature of Work, the Date of Commencement and Date of Completion of the work.
- 2. The bidder shall have achieved at least two financial years a minimum financial turnover not less than the two times the estimated annual payment under this contract in all civil Engineering works in last 5 years. The bidder shall submit balance sheets as proof of having annual turn over as above, which shall be duly certified by a Chartered Accountant.
- 3. Tenderer shall furnish list of Equipment and Machineries possessed by him / her.
- 4. The bidder shall have Present net worth not less than 75% of amount put to tender.
- 5. The bidder should submit assessed available tender capacity and BAR / PERTH chart for respective works mentioned in the notification.
- 6. The bidder must submit line of Credit for an amount equal to 30% of the estimate cash flow in peak construction period issued by Nationalized/ Scheduled Bank of original, for the tendered work.
- 7. The bidder shall submit latest income tax paid certification from the income tax department from last five financial years.
- 8. The tenderers shall furnish a cash flow chart on month basis for the entire period of execution of the work.
- 9. The bidder must submit Provisional programme for completion of various items of work.
- 10. ISO Certification for the equipment manufacturing, marketing, servicing and establishment should be uploaded.
- 11. Instruction to bidders (for short the ITB) provided that the bidders shall quote (i) the basic price (including all taxes and duties etc., but excluding GST) and (ii) applicable GST 12% as asked for in the bill of quantities.
- 12. The agency has quoted the latest Karnataka Labour department minimum wages to the labors apply for the cleaning and security work
- 13. The agency should be registered with I.T, E.S.I, P.F, Labour Department,, Police department (ISD), GST registration and other statutory authority of Government of Karnataka are eligible to apply for the cleaning and security work.
