The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.

Tenders must be accompanied by earnest money deposit which should be paid online through KPP portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) within the date and time published in KPP portal. Tenders will be opened at prescribed time and date in the KPPportal, in the presence of the Tenderers who wish to attend at the OFFICE OF THE EXECUTIVE ENGINEER, Mahadevapura Division, BBMP office, Mahadevapura, Bangalore- 560 048 Other details can be seen in the tender documents.

TERMS & CONDITIONS:

1. Any reputed Individual / Company registered with BBMP/CPWD/KPWD/Railways/MES or any State Government Organizations are eligible to apply.
2. **Class I:** Contractors shall have completed at least one single work in all respects, the cost of which is not less than Rs.5 crore and the total turnover should be over Rs.15 crore in the preceding five years.
3. **Class II:** Contractors shall have completed at least one single work, in all respects the cost of which is not less than Rs.1 crore and the total turnover should be over Rs.3 crore in the preceding five years.
4. **Class III:** Contractors shall have completed at least one single work, the cost of which is not less than Rs.50 lakh and the total turnover Rs 1 crore in the preceding five years.
5. **Class IV:** Contractors shall have completed at least one single work, the cost of which is not less than Rs.5 lakh and the total turnover Rs 15 lakh in the preceding five years.
6. No Joint Venture / Consortium is not permissible.
7. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore MahanagaraPalike for the block period of 2018-2023 should be enclosed with the tender documents.
8. The Bruhat Bangalore MahanagaraPalike reserves the right to accept /reject any or all the Tenders without assigning any reasons.
9. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
10. The Work shall be commenced with all Men and Machinery **within 7 days** from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
11. Tenderer who have the works pending with them will not be entertained. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason thereof.
12. The Income Tax at the rate of 2.30%, GST as applicable and Cess at 1% will be deducted and certificate will be issued in favor of the Contractor from every running bill / final bills of the contractor: Upload the GST Registration Certificate.
13. The rates quoted in the schedule shall be inclusive of all taxes applicable.
14. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
15. The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
16. Sub-Letting of work is prohibited.
17. The defect liability period for civil works & Asphalt works period is **Two year** from the date of final bill. The Performance security amount will be refunded only after the defect liability period.
18. Tenderers can submit the tenders for all the works, However this is subject to fulfillment of tender capacity condition and all as per standard tender document for procurement of works KW-2&3
19. Frequency of the quality test of all the materials and other tests have to be conducted by the contractor as per MORT & H (IV th Revision) I.R.C. guidelines and other relevant Indian standards in his laboratory or any other laboratory assigned by BBMP on his own cost in presence of Engineer / consultants appointed by BBMP Further Details of the Work can be obtained from the Office of the Executive Engineer, Mahadevpura Division, BBMP office, Mahadevpura Bangalore - 560 048 on all Working Days during office hours.
20. The successful Tenderer shall execute an Agreement **within 7 days** from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
21. As per Government order no. LD 300/LET/2006, dt: 18/01/2007, 1% of the Estimated Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.

23. Balance EMD in the form of BG/FDR in favour of Executive Engineer, Mahadevpura Division, BBMP should be submitted to the office of the Executive Engineer, Mahadevpura Division, before the date of opening of the technical bid failing which such Tender remains cancelled.
24. The successful Tenderer shall pay the Performance security and Difference amount if any within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.

25. GST will be paid to the tendered amount separately.
26. The Tender Notification along with Blank Tender Form will be accessible in the procurements website (www.kppp.karnataka.gov.in)
27. Any further corrigendum/addendum in this regard will be published in kppp portal only for the information of the contractors.
28.
