After login to Contractors, we scroll down to the left side bottom to see List of Tenders, Please click there to find the details of NIT and download copy of the tender. The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.

Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal, in the presence of the Tenderers who wish to attend at the OFFICE OF THE EXECUTIVE ENGINEER, K.R.Pura Division, BBMP office, K.R.Pura Bangalore - 560 036. 
TERMS & CONDITIONS:

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium is permissible.
3. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period should be enclosed with the tender documents.
4. The Tender Document will form the part and parcel of the Agreement.
5. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
6. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
7. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason there of.
8. The rates quoted in the schedule shall be inclusive of all taxes applicable.
9. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not Eligible to quote, if found such Tenders will be rejected.
10. The successful Tenderer shall pay the Difference Cost within 20 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.

12. As per Government order no. LD 300/LET/2006, dt: 18/01/2007, 1% of the Estimated Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.

Frequency of the quality test of all the materials and other tests have to be conducted by the contractor as per MORT&H (IV th Revision) I.R.C. guidelines and other relevant Indian standards in his laboratory or any other laboratory assigned by BBMP on his own cost in presence of Engineer / consultants appointed by BBMP
