Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.

Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal , in the presence of the Tenderers who wish to attend at the OFFICE OF THE EXECUTIVE ENGINEER, K.R.Pura Division, BBMP office, K.R.Pura Bangalore – 560 036. - Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / or any State Government Organizations are eligible to apply.
- 2. No Joint Venture / Consortium is permissible.
- 3. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period should be enclosed with the tender documents.
- 4. The Tender Document will form the part and parcel of the Agreement.
- 5. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
- 6. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
