- A) The Senior Assistant Director of Horticulture (Dasarahalli Zone, BBMP), (Referred to as Employer in these documents) invites tenders in accordance with KTPP rules 2000, from eligible and experienced Person/Agencies / Firms (Referred to as Tenderers in these documents) registered in Labour department for Maintenance of Parks in Dasarahalli Zone, Bengaluru, Karnataka.

Only Interested Tenderer who wishes to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable.
- D) Tenders must be accompanied by Notarised Earnest Money Deposit (EMD) declaration format attached with this document
- E) Tenders must be electronically submitted (online) within the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal, in the presence of the Tenderers who wish to attend in the Office of The Senior Assistant Director of Horticulture, , **Dasarahalli Zone**, BBMP Bengaluru-560073
- F) Tenderers are subjected to the provisions of KTPP (Amendment) Rules 2017 and selected works in Randomization shall be reserved for participation by tenderers belonging to the scheduled castes & scheduled tribes.
- G) The Tenderer will be selected under low cost selection (LCS) Procedures (the Tenderer who quotes lowest rate)

TECHNICAL BID QUALIFICATION CRITERIA:

a. For general category works:

Tenderer should submit work done certificate, least for one work in the field of horticulture park maintenance or horticulture landscape development work (civil development work in parks will not be considered) to an extent of 50% of the total tendered amount in last five financial years (2016-17 to 2020-21) of its work. The work done certificate should duly certified by the competent authorities (Central Govt/State Govt / Govt Boards / Govt Corporation). This condition is also applicable to tenderer of Scheduled caste & Scheduled Tribes who is participating in General category works.

b. For Scheduled Caste & Scheduled Tribes reserved works:

Tenderer should submit work done certificate at least for one work in the field of horticulture park maintenance or horticulture landscape development work (civil development work in parks will not be considered) to an extent of 25% of the total tendered amount in last five years (2016-17 to 2020-21) of its work. The work done certificate should duly certified by the competent authorities (Central Govt/State Govt / Govt Boards / Govt Corporation).

- c. The Competent authority issuing work done certificate should mention complete postal address and Contact number (Office Land Line, e-mail id and Mobile number).
- d. Tenderer should submit the copy of turnover statement of last 5 financial year (2016-17 , 2017-18, 2018-19 & 2020-2021)
- e. The Tenderer should submit notarised copy of valid Labour Department License, P.F & ESI registration Certificate notarised copies along with tender documents.

- f. The tenderer should submit notarised copy of valid PAN card and GST registration Certificate notarised copies along with tender document.
- g. Tenderer participating for works reserved for SC/ST shall upload Caste Certificate issued by competent authority. The Contractor belonging to the Scheduled Castes or Scheduled Tribes shall be domicile of the State of Karnataka for more than 10 Years & if the contractor is a firm, then all the partners or members of the firm shall belong to the Scheduled Castes or Scheduled Tribes as the case may be. Same documents (Caste & Domicile certificate) have to be notarised & uploaded along with tender document.
- h. The Annexure-1 attached with this notification regarding the Technical bid details has to be filled and duly signed by the Tenderer, notarised and uploaded with the other documents.
- i. Document uploaded should be notarised by Notary.
- j. "Line of Credit" issued by banks should mention the name of work, the amount of credit being approved. For each work a separate Line of Credit should be attached.
- k. Work done certificate for the work done through "sublet" will not be considered.
- l. Work done certificates for the supply of manpower/labourers to horticulture work will not be considered.


