The Work Completion Certificate shall mention the Nature of Work, the Date of Commencement and Date of Completion of the work.
2. The bidder shall have achieved at least two financial years a minimum financial turnover not less than the estimated annual payment under this contract in all civil Engineering works in last 5 years. The bidder shall submit balance sheets as proof of having annual turn over as above, which shall be duly certified by a Chartered Accountant.
3. Tenderer shall furnish list of Equipment and Machineries possessed by him / her
4. The bidder shall have Present net worth not less than 75% of amount put to tender.

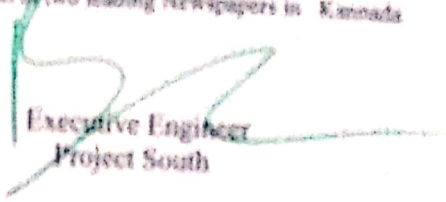
