- 1. The Tender Notification along with Blank Tender Form will be accessible on the website of GOK e- Procurement Platform (http://eproc.karnataka.gov.in) website. The intereded contractors / suppliers may download the tender documents.
- 2. Tender documents may be downloaded from Government of Karnataka e-Procurement http://eproc.karnataka.gov.in Bidders/Contractors who have not registered in e-procurement should register before participating through the website https://eproc.karnataka.gov.in or contact e-Procurement Helpdesk at 080 - 22485867 / 22485927.
- 3. The contractors shall submit the digitally signed tenders electronically on or before the date and time of submission published in the e-procurement portal.
- 4. Rates quoted should be exclusive of GST. GST will be paid separately.
- 5. The Tender will remain valid for **180 Days** from the Date of Opening of Tender. 6. The Contractor is not eligible for submission of application for tender form if he has not put the tender after purchase of the tender document continuously for three times.
- 7. The Contractors / Contract firms shall have a valid Contract Licence on the last date of submission of tenders (extended date if any) for the further period of 180 days from BBMP or PWD (Both State / Central Govt Departments, Boards and Corporations Owned and Controlled by Govt.) etc. But they must produce / or obtain the Valid BBMP Contract Licence before entering into the Agreement as per Commissioner Office Order Dated: 30-03-2021. (To be Valid for Minimum 6 months from Date of last date for submission of tenders
- 8. The Successful tenderer will have to execute an agreement with BBMP within 20 days of receipt of intimation of Letter of Acceptance, failing which his tender will be summarily rejected without giving any further Notice.
- 9. The Contractor / Agency shall intimate the change, if any, in any of the addresses, in advance or maximum within one week of such change along with acknowledgement of noting down of such change in address from the bank, Income tax, GST authorities etc. Failure to do so liability lies on the Contractor / Agency whatsoever.
- 10. The Work shall be commenced with all Men, Material Tools and Plants within 7 days from the Date of Work Order, failing to which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tendered.
- 11. Defect Liability Period (DLP) and Maintenance Period will be as per Commissioner Order No: ಆಯುಕ್ತರು/ಪಿ.ಆರ್/318/2010-21 ದಿನಾಂಕ: 03.02.2021
- 12. FSD will be refunded only after Expiry of Defect Liability Period (DLP).
- 13. Frequency of the Quality tests of all the materials and other tests have to be conducted by contractor as per Specifications for Road and Bridge Works (5th Revision) and IRC:SP:11-1984 Handbook of Quality Control for Construction of Roads and Runways, IRC:SP:112-2017 Manual for Quality Control in Road and Bridge Works, IRC:SP:47-1998 Guidelines on Quality Systems for Road Bridges (Plain, Reinforced, Prestressed), RC:SP:57-2000 Guidelines for Quality Systems for Road Construction and Composite Concrete and Spara Palike

- 2005 National Building Code of India & other relevant Indian standards in his laboratory or any other Laboratory assigned by the BBMP on his own cost in presence of Engineer/consultants appointed by BBMP.
  - 14. For Asphalting works, like Pothole filling, Chip Carpeting, B.M & B.C etc., those who own their hot mix plant / batch mix plant & mechanical paver / sensor paver only need apply. Such of those tenderers will have to furnish the list of machinery equipment along with the copy of the Registration Certificate at the time of scanning of tender documents.
  - 15. As per Govt. Order No: LD 300/LET/2006, Dated: 18.07.2007, 1% of the bill amount will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
  - 16. The Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the Instructions to Tenderers to qualify for award of the contract (Standard Tender Document) also Tenderers are advised to go through the Standard Bid Documents.
  - 17. Any Corrigendum / Modification will be notified in the Notice Board of the Undersigned. And also will be published in e-portal.
  - 18. The BBMP reserves the right to accept / reject any or all tenders without assigning any reasons whatsoever.
  - 19. As per Government Circular No: ಗಭೂಇ/ಡಿಸಿಬಿ/2020-21, ದಿನಾಂಕ: 03-07-2020ರಂತೆ the contractors are liable to pay royalty in terms of the contract if they are not able to produce the materials purchased document / MDP's from where they purchase.
  - 20. Blacklisted Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
  - 21. All the participants should produce all the original documents for verification whenever necessary.
  - 22. The work shall be carried out as per the directions of the BBMP and if necessary, in coordination with BESCOM, BWSSB, Other Utility Agencies and Engineer in charge of Work.
  - 23. No Joint Venture / Consortium is permissible.
  - 24. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderers.
  - 25. Conditional Tenders will not be entertained, and they are summarily rejected.
  - 26. Further particulars can be had from the office of the Executive Engineer, C.V.Raman Nagara Division, and BBMP during the working days between 10.00 A.M. to 5.30 P.M.
  - 27. The Construction Debris Generated from Work Shall be dumped in Designated Dumping Yards Only.
  - 28. If the Contractor has any liability whatsoever to the BBMP / Govt the same will be deducted from the Contractors bills.
  - 29. Bidder shall submit the bids electronically before the stipulated date and time for the submission published in e-procurement portal. No tenders can be submitted after the due Executive Engineer

- date and time as the portal will not accept late tenders. No documents will be accepted physically to this office.
- 30. The contractor / supplier can modify and correct or upload any other relevant document in the portal before last date and time of submission on e-portal. No modifications or withdrawal of tender is possible the closing time of the submission of the tender.
- 31. In the event of the specified date of tender opening being declared a holiday for the tender inviting authority, the tenders will be opened the next immediate working day.
- 32. As per Commissioner inter Office Note No: ఆ/పిఆరో/1629/18-19 Dated:18-08-2018. The Contractors to Implement/Entrusted the works in 3 shifts.
- 33. Bidders is advised to submit the one set of Hard Copy with spiral Binding of all documents which are uploaded in the e-portal to this office before opening of the Tender.
- 34. The Works reserved for SC/ST category relaxation of Tender clauses will be applicable as per Government order No: FD 876 Exp-12/2017, Dated: 10-10-2017 and all applicable Acts / rules / Notifications / any other orders of Govt / BBMP are applicable as on date and amended as and when they amended / modified. All the relevant certificates / documents which are issued by the competent authority are to uploded in e-portal.
- 35. As per Commissioner BBMP Office order No. Comm/PR/3360/2020-21 Dt: 30.03.2021, all bidders here by instructed register themselves in BBMP and upload the same in E-portal, those who are registered in other Govt organization their Tender will be honored, but they must register themselves before getting work order from this office. Otherwise, such tenders will be cancelled (i.e., After Letter of Acceptance is issued before the last date for entering into an agreement).
- 36. All the notifications /orders passed by Govt / Chief Commissioner BBMP will be applicable as and when issued / amended.
- 37. The successful bidder should upload the workplace photograph and work done on silt and debris mobile app developed by BBMP as per report of mobile app the payment will be made on monthly basis.
- 38. EMD / FSD & further FSD (for unbalanced tenders) will be as per KTPP Act 1999 / rules 2000 / Any Government notifications as applicable.
