### URBAN DEVELOPMENT SECRETARIAT DRAFT NOTIFICATION

NO. UDD 1107 MNU 2015, Bengaluru, Dated : 27.11.2018

WHEREAS, Section 321-B was inserted by Act 1/2007, wherein it was directed that the jurisdictional officer who is proved to have failed to prevent unauthorized deviation or construction that have taken place in his jurisdiction shall be liable for such punishment as may be prescribed.

WHEREAS, deviations and unauthorized constructions may not complete in a day or two. It may complete or may not complete during the tenure of a particular jurisdictional officer. Right from digging of the earth till obtaining of occupancy certificate, etc., there could be number of jurisdictional officers. The punishment has been prescribed keeping in view of the contribution of default of each jurisdictional officer incharge.

Therefore, punishments for various offences under Chapter XV of the Karnataka Municipal Corporations Act, 1976 and under the Building Bye-laws, 2003 which has to be prescribed under Section 321-B of K.M.C. Act, 1976 have been listed as below, for the information of all the persons likely to be affected thereby. Notice is hereby given that the said draft will be taken into consideration and finalized after thirty days from the date of its publication in the Official Gazette.

Any objections or suggestions which may be received from any person with respect to the draft notification before the expiry of the period specified above will be taken up for consideration by the State Government and finalized.
