# BJP plans big Bengaluru push with Modi's visit ahead of polls

The Chief Minister has been on an inauguration spree of development projects

The Bharatiya Janata Party is planning a big Bengaluru push to launch its campaign for the upcoming civic polls and the 2023 Assembly polls, starting with Prime Minister Narendra Modi's visit to the city on Monday.

The Prime Minister will address a public rally at Kommaghatta after laying the foundation stone for the much delayed ₹15,000-crore suburban rail project. The BJP has planned a grand welcome with a large number of workers in attendance after he lands at Yelahanka Air Force Base. Arun Singh, incharge of BJP Karnataka, is scheduled to arrive in the city on Friday and stay here till the Prime Minister leaves the State. "Ahead of civic polls in the city, the Prime Minister is coming to lay the foundation stone for a mega infrastructure project and we will definitely make the best use of it," a senior leader said.

The Supreme Court, on May 20, set a eight-week deadline for ward delimitation and reservation roster for Bruhat Bengaluru Mahanagara Palike (BBMP) to be completed and elections be held subsequently, setting the stage for the civic polls in August-September 2022. BBMP has already submitted a draft of the delimited wards.

#### Series of inaugurations

Since then, Chief Minister Basavaraj Bommai, who also holds charge of the city, has gone on a development project-inauguration spree in Assembly constituencies represented by BJP in the city.

In the last 10 days, Mr. Bommai has inaugurated a slew of development works in Govindaraj Nagar, R.R. Na-

gar and Chickpet constituencies. More such events, including the inauguration of the first phase of K-100, a reimagining of storm-water drains in the city, are planned, sources said. "The plan is to project a development image for the government in the city and ensure the works are visible to the people. Most of the projects being inaugurated now are

from the time of B.S. Yediyurappa and the Chief Minister is laying foundation stone for other new works as well," a senior civic official said.

#### Rains and after

The havoc created by recent rains in the city has left a bad taste in the mouth of the citizens and the pathetic condition of roads became a talking point in cyberspace too.

To make a course correction in this image, the party has decided to push for a development agenda for the city, sources said. The Chief Minister was keen and pushed the filling of potholes and remaking roads on a war footing, as a first step, senior civic officials said. Laying the foundation stone for the much delayed mega infraproject suburban rail by Mr. Modi is part of the same campaign, officials close to the Chief Minister said.

At multiple events in the city over the last 10 days, the Chief Minister has been talking of a vision document to decongest Bengaluru, to improve connectivity with mega-infra projects of suburban rail and peripheral ring road and spending ₹1,600 crore to redo storm-water drains to prevent flooding. He has also announced a slew of welfare schemes like restarting "onti mane" scheme, government providing bank guarantee for beneficiaries of housing schemes and implementing Akrama-Sakrama, with an aim to woo the poorer sections, sources said.

### Karnataka among two States to host One Health pilot

The exercise, with focus on zoonotic diseases, will be launched on June 28; learnings from it will be used to develop a national framework

Karnataka will be one of two States where the 'One Health' programme will be piloted, the other State being Uttarakhand.

Set to be launched on June 28, the pilot will be used to develop a national One Health Framework, a key objective of the One Health Support Unit initiated by the Department of Animal Husbandry and Dairying (DAHD), Government of India.

The framework is aimed at improving national and State-level resource allocation and policy ecosystem on early prediction, detection, and diagnosis of zoonotic diseases through increased quality, availability, and utility of data evidence.

Speaking to *The Hindu*, Atul Chaturvedi, Secretary, DAHD, said, "At the global level, four organisations

-World Health Organization, Food and Agriculture Organization, World Organization for Animal Health, and the United Nations Environment Programme - have joined together to work out strategies as far as the inter-relatedness and the way to move forward for One Health are concerned. As a concept, it is as-

sumed that any health matters are all interrelated with each other and we cannot treat human, animal or wildlife health in isolation," he said.

In India, the government has been taking many initiatives to arrive at implementing the One Health concept, he added. "Since the bridge

between the human and wildilife health are the domesticated animals, which are the carriers of a lot of diseases between human beings and wildlife, or which starts from the livestock sector and gets transferred to human health, the DAHD decided to operationalise this concept where all three platforms start talking and reporting to each other and do capacity building so we start asking the right questions to each other," he explained.

Apart from an apex interministerial governance committee chaired by the Principal Scientific Adviser to the Government of India, a Project Steering Committee (PSC) chaired by the Secretary, DAHD, comprising of authorities from the Ministry of Health and Family Wel-

fare, Ministry of Environment, Forest and Climate Change, ICAR, civil societies, international development organisations, and field practitioners. Along with this, there will be a State-Level One Health Committee.

The two States were chosen, said Mr. Chaturvedi, based on an exercise of identifying operational parameters – infrastructure related to diagnostic facilities, digital interventions, occurrences of zoonotic diseases, responsiveness, and proactive administration in responding to those diseases, and non-operational parameters such as human-animal interaction index, each investock disease diversity index – on which all States were graded.

The top five States based

The top five States based on this were Uttarakhand, Karnataka, Assam, Maharashtra, and Odisha in that order, of which the top two States were chosen. The pilot in Uttarakhand

was launched in April. Based on the recommendations of the PSC, six interventions have been planned for the pilot in Uttarakhand and Karnataka, including institutionalising the mechanism for data collection on disease outbreak, prevalence, management, and development of targeted surveillance. It also entails integrating the net-work of laboratories with a focus on strengthening com-munication and lab testing capacities around zoonotic diseases, developing a communication strategy across sectors with an emphasis on livestock and animal healthrelated issues, and integra-tion of the data with the digital architecture of the Nation al Digital Livestock Mission to enable the analytics needed for the development of One Health Programme.

# Daily COVID-19 cases cross 12,000 mark

A total of 12,213 cases were reported in a span of 24 hours, taking India's total tally of COVID-19 cases since the onset of the pandemic to 4,32,57,730 while the death toll has climbed to 5,24,803 with 11 fresh fatalities, the data updated at 8 a.m. stated.

India had reported over 12,000 COVID-19 cases on a single day the last time on

February 24, when it reported 13,166 new cases.

The daily test positivity rate was recorded at 2.35% while the weekly positivity rate was at 2.38%, according to the Health Ministry. Mumbai has reported the highest number of new cases, 2,366, taking the active caseload there to 13,005. The 11 new fatalities include three from Kerala.





# Covid: Positivity rate rises outside Bengaluru, woman dies in Belagavi

BENGALURU, DHNS: Fresh Covid cases reached almost 800 in Bengaluru on Wednesday, as per the health bulletin.

Karnataka reported 833 new cases, including 791 in Bengaluru.

The positivity rate is steadily rising outside Bengaluru. The state-wide positivity rate stood at 3.47% out of 23,990 samples.

In Bengaluru, it was 3.26% out of 18,195 samples. During the day, there were 458 discharges, including 435 in Bengaluru.

A 35-year-old woman from Belagavi who had Influenza-Like Illness (ILI) and was suffering from TB, died after being in hospital for 12 days. She was admitted on June 1 and died on June 12.

Karnataka has 4,371 cases, including 4,199 in Bengaluru alone. In the city, 26 people are in hospital.

Three of them are in ICU and two in HDU.

There are 18 Covid clusters in Bengaluru. Fifteen have more than five cases each and the rest fewer than five cases each.





### Can't afford to ignore long-term Covid symptoms, warn experts

# Patients experience fatigue, cognitive, respiratory issues

even as the number of Covid infections sees an upward trend in the country, a global study has suggested that apart from tracking new infections, there is also a need to address long-term Covid symptoms.

According to the pre-print of the global survey, conducted by researchers from across the world, 144.7 million people suffer from long-term Covid symptoms such as fatigue, cognitive problems and respiratory problems.

The study showed that across India over 11 million incidents of long Covid were reported in 2020 alone. The numbers could be up to 27.9 million for 2021.

Of the 144.1 million, fatigue could be observed in 51%, cognitive problems in 35.4%, and respiratory problems in 60.4%. Also, 38.4% of themexperienced multiple problems.

The findings show that 15.1% of those who suffered from long Covid had not completely recovered even after a year of being infected.

The study suggested that there was a need to establish rehabilitative care and support, to help those suffering from long Covid to transition back to the workplace or education.

Speaking to *DH*, Dr Giridhar Babu, epidemiologist and member of Karnataka State Covid technical advisory committee, said there was a need to sensitise people and doctors on long Covid.

"Assuming that a majority

of our population could be infected, there is a need to track people who could be suffering from long Covid and sensitise both people and doctors to handle the situation better. Long Covid has to be considered seriously," he said.

He said there was a need to implement better workplace policies. "Workplaces should implement better sickness benefits to support those suffering from long Covid," he caid.

The study also showed that long Covid prevalence was high among females at 63.2% and the peak age was set between 20 and 29 years.

### Over 5k samples collected for paediatric serosurvey

BENGALURU, DHNS: The Health department, which launched the paediatric sero-survey last week, has completed the fieldwork by successfully collecting 5,360 samples as against the target of 5,072 samples.

The survey is aimed at assessing the antibody prevalence in children between the age of six years and 14 years. According to the Department of Health, 785 samples have been collected in the BBMP limits and 494 samples in Belagavi. With 40 samples, the least number of samples have been collected from Kodagu. Though the state had conducted two rounds of serosurvey previously, the present survey holds importance since it is being conducted on

children, a majority of whom could be unvaccinated.

Dr Giridhar Babu, epidemiologist and TAC member, said the survey results would prioritise the measures. "Earlier, the seroprevalence in adults was ascertained. It is important to study the virus seroprevalence in children since many of them could be unvaccinated," he

# BBMP elections: Will Bengaluru get a better deal?

The first desirable thing, soon after the elections, is for the Area Sabhas to be notified and the Ward Committees set up

whith the Supreme Court cracking the whip against state governments and ordering that all pending local body elections should be scheduled within two weeks, the state government has had to buckle down and put an end to its arbitrary and impudent procrastination of BBMP elections since September 2020 in violation of the Constitution. Several citizens' groups under the banner of 'Civil Society Forum' have come up with their own manifesto to be presented to political parties before the BBMP election envisioning a better Bengaluru.


This delay in elections has happened by delaying the delimitation of wards and reservation of seats, a task that should be assigned to the State Election Commission but has been usurped by the State government. This power must be given back to the SEC to avoid future strictures by the SC for not holding elections on time.

BBMP is facing a myriad of crises and paradoxes. There is massive corruption in road contracts, as revealed by the Contractors' Association itself, resulting in pothole deaths of several citizens. Largescale encroachments of lakes, rajakaluves and buffer-zones are causing frequent flooding of houses, especially of the poor, while these same poor may be struggling for access to regular supply of piped water or basic sanitation. High-rises mushroom amidst slums, often in violation of zoning and building bye-laws. High-end infrastructure for private cars is prioritised while the losses of the BMTC, carrying the largest number of commuters, are not covered.

Open garbage heaps, polluted, frothing and burning lakes, and poisoned air are the norm even as the city boasts of being the IT-BT capital, 'start-up' hub and the 'silicon plateau' of the world. Officials, even after they are hauled up for contempt, ignore Court orders on these issues with brazen impunity, and lack resulting in total lack of accountability. Why are these officials, who have allowed thousands of blatant violation of laws, not punished and instead 'enquiry teams' are setup to delay, whitewash or divert attention from their open misdoings?

The 'Right to the City' – basic entitlements to housing, water and sanitation, health, education, employment, and social security – are denied to those who actually build and serve the city; their homes are demolished or they are pushed to the periphery with their livelihoods destroyed.

Local self-government with transparency, accountability and people's participation as envisaged in the 74th Constitutional Amendment for urban local bodies standsvitiated in Bengaluru with the state government and MLAs usurping the role of what is supposed to be a 'local self-government'. An MLA-chaired committee at the Assembly Constituency-level has even been introduced into the new BBMP Act



between the ward and zonal committees, in total violation of the 74th CA.

Participation of every voter in the planning and governance of his area has been denied by non-implementation of the provision for 'Area Sabhas' since 2011. The ward committees have been completely crippled now in the BBMP Act with their decisions being rendered 'advisory' innature as there is no political will to share power with people.

BBMP will have to go beyond its current focus solely on roads, potholes, drains and garbage and fulfil the broader function assigned to local self-governments under the Nagarapalika Act of "planning for economic development and social justice".

Soon after the election, the first desirable thing is for the Area Sabhas to be notified and the Ward Committees set up within a month. These bodies need to develop a '5-year Ward Vision Plan' in

a bottom-up, evidence-based participatory planning process, setting targets to achieve human development, social infrastructure and ecological sustainability goals – in short, localisation of the Sustainable Development Goals (SDGs). This will also provide a basis for judging the performance of the councillor at the end of his/her five-year term. An exclusive website for each ward, where its Ward Vison Plan would be uploaded, will help monitor progress and also make it easier to provide regular updates.

For localising the SDGs, it would be necessary to first of all devolve to the municipality the 3Fs – funds, functions and functionaries – for slum upgradation, running of all the PDS shops, anganwadis, elementary schools, primary health centres, vocational/skill training centres, and such others, many of which are currently controlled by line departments of the State government. These have been already devolved to the Panchayat Raj Institutions in rural areas.

The citizens' participatory platforms for monitoring the functioning of these institutions, such as the vigilance committees of ration shops, balavikas samitis of anganwadis, SDMCs of schools and Arogya Raksha Samitis of PHCs among others, need to be strengthened. These committees already have the local councillor as either a member or chairperson. But most councillors do not utilise these roles fully to improve the services of these institutions which are so critical for the upliftment of the marginalised and to achieve SDGs. Many of these committees exist on paper only with ghost members and ghost minutes of meetings. Information on the members of these committees, the minutes of their meetings and actions taken needs to be uploaded on the exclusive website of each ward.

The website must also carry information on the funds flowing in to the ward through various government departments, and their usage, and not just on the BBMP's work on roads, drains, etc. To facilitate this, the government recently accepted a recommendation for Treasury to assign a unique ID to each ward, which will be cited on every expenditure. This way, information on funds from various sources reaching the wards will be available on the Ward websites thereby enabling social auditing and increased accountability.

With fresh elections coming, this is an opportunity for all political parties to demonstrate their genuine commitment to build a better Bengaluru wedded to Constitutional values.

# NTAGI recommends reducing booster dose gap to 6 months

NEW DELHI, PTI: The Standing Technical Sub-Committee (STSC) of the NTAGI on Thursday recommended reducing the gap between the second and precaution doses of Covid-19 vaccines from the current nine to six months, official sources said.

They said the health ministry will take the final call on the recommendation soon.

The government advisory panel, which met on Thursday, also reviewed the findings of a study by the Christian Medical College (CMC) in Vellore on the feasibility of allowing as a precaution dose a Covid vaccine different from the one used for primary vaccination.

The panel members found a lack of uniformity in results upon mixing of jabs for booster shots and stated that no recommendation for it can be made as of now. The CMC study was on Covishield and Covaxin.

The threat of monkeypox and the requirement of vaccination were also discussed in the meeting of the panel of the National Technical Advisory Group on Immunisation (NTA-GI), the sources said.

"However, the members were of the view that a strong surveillance is what is required as of now. No case of monkeypox has been detected in the country till now," one of the sources told PTI.

The panel also reviewed data on Covaxin and Corbevax vaccines for the 6-12 age group.

"The members opined that data of Covid burden and mortality among children is not robust enough to take any decision to begin vaccination of those below 12 years," the source stated.





# At 4,255, Maha logs highest Covid cases in over 4 months

aharashtra on Thursday recorded 4,255 new coronavirus cases, the highest daily count since February 12, while three more patients succumbed to the infection even as the active tally crossed the 20,000-mark, the state health department said.

With these additions, the state's overall Covid-19 tally rose to 79,23,697, while the death toll increased to 1,47,880, the department said in a bulletin. A day before, the state had recorded 4,024 new cases and two deaths linked to the infection.

The fresh tally of 4,255 was the highest since February 12 when the state had recorded 4,359 cases.

### India reports 12,213 new cases

The single-day rise in new coronavirus infections were recorded over 12,000 after 111 days, registering 38.4% jump in daily cases while the active cases have increased to 58,215, according to the Union Health Ministry data on Thursday.

A total 12,213 cases were reported in a span of 24 hours, taking India's total tally of Covid-19 cases to 4,32,57,730 while the death toll has climbed to 5,24,803 with 11 fatalities, the data updated at 8 am on Thursday stated.

As many as 2,879 patients recovered from Covid-19 in the state since previous evening, pushing up their cumulative count to 77,55,183 and leaving the state with 20,634 active cases, the bulletin said.

The recovery rate in the statestood at 97.87%. Nandurbar is the only district which

does not have active cases currently. Two more cases of B.A.5 sub-variant were reported in the state on Thursday, the health department said.

According to a report of the National Environmental Engineering Research Institute, the two patients were detected in Nagpur.

India's drug regulator in April this year had granted emergency use authorisation for Corbevax for those aged five to 12 years and Bharat Biotech's Covaxin for children in the age group of six to 12 years. The STSC members were learnt to have also agreed on administration of an additional third dose for renal transplant patients before the precaution dose.

# Covid deaths up 4% worldwide, reversing 5-week decline: WHO

Geneva: After five weeks of declining coronavirus deaths, the number of fatalities reported globally increased by 4% last week, according to the World Health Organisation.

In its weekly assessment of the pandemic issued on Thursday, the UN health agency said there were 8,700 Covid-19 deaths last week, with a 21% jump in the Americas and a 17% increase in the Western Pacific. WHO said coronavirus cases continued to fall, with about 3.2 million new cases reported last week, extending a decline in Covid-19 infections since the peak in January. Still. there were significant spikes of infection in some regions, with the Middle East and Southeast Asia reporting increases of 58% and 33% respectively.

"Because many countries have reduced surveillance and testing, we know this number is under-reported," WHO director-general Tedros Adhanom Ghebreyesus said earlier this week. He said there was



WHO said coronavirus cases continued to fall, with about 3.2m new cases reported last week. But there were spikes of infection in Middle East (58%) and in Southeast Asia (33%)

"no acceptable level of deaths from Covid-19," given that the global community now has the vaccines, medicines and diagnostics to stop the virus.

While many rich countries in Europe and North America have mostly dropped their virus restrictions, China's extreme Covir-19 policies have meant more mass testing, quarantines and sequestering of anyone who was in contact with a case. China's capital put school back online this week in one of its major districts amid a new

Covid-19 outbreak linked to a nightclub. Residents in Beijing are still undergoing regular testing — mostly every other day — and must wear masks and swipe a mobile phone app to enter public places and facilitate case tracing. China has maintained its "zero-Covid" policy despite considerable economic costs and an assertion from the head of the WHO that the policy isn't sustainable.

This week, US officials moved a step closer to authorising coronavirus vaccines for the youngest children, after the FDA's vaccine advisers gave a thumbs-up to vaccines from Moderna and Pfizer-BioNTech for children under 5. The outside experts voted unanimously that the benefits of the shots outweigh any risks for children under 5-that's roughly 18 million youngsters. They are the last age group in the US without access to Covid-19 vaccines. If all the regulatory steps are cleared, shots should be available next week. AP

## **4cr Indians reported long Covid symptoms**

Global Study Finds 3 Key Ailments; B'luru Docs Say Rehab Support, Sensitivity Important

Bengaluru: If you have been suffering from fatigue, respiratory problems or brain fog even months after recovering from Covid-19, you are not alone. A global study has found that in India alone, nearly four crore people expe rienced these symptoms of long Covid since 2020.

The number is more than 14 crore globally.

A paper -'A global systematic analysis of the occurrence, severity, and recovery pattern of long COVID in 2020 and 2021'—revealed startling details. It was published by a

ere affected by long Covid. The paper, which was published on medRxiv (a free online archive and distribution server for complete but unpublished manuscripts in medical, clinical and related health sciences), said a substantial number of people with long Covid need rehabilitative care and support to transition back into workeducation when place or symptoms start to wane.

"While much attention during Covid-19 pandemic was directed at daily case counts and those with serious disease overwhelming health increasingly, ports have appeared of people who experience debilitating symptoms after the initial infection. This is known as long Covid," the researchers, who found 84 long-term effects of Covid-19, said.

Dr Giridhar Babu, professor, head - lifecourse epidemiology - Indian Institute of Public Health Bengaluru, Public Health Foundation of India, told **TOI** the study proves that Covid-19 can neither be dismissed as just another flu nor should it be dreaded. ### 'Lack of coordination between forest dept and BBMP'

t seems as though the state forest department will not fix a fence until one or two hapless pedestrians fall into the Hebbal Lake.

With a portion of the retaining wall of the lake collapsing near the flyover, walking on the footpath has become dangerous for pedestrians.

The problem is the lack of coordination between the state forest department and Bruhat Bengaluru Mahanagara Palike (BBMP).


The footpath development was taken up by the BBMP a year ago without informing the state forest department about the collapsed retaining wall and damaged fence. The result: a stretch of the developed footpath collapsed along the retaining wall inconveniencing the pedestrians.

Criticising the BBMP for not ensuring quality and the failure to take precautions before embarking to develop the footpath, traffic expert Sanjeev Dyamannavar said the BBMP had engaged a contractor to develop the footpath but the work remains incomplete even after a year.

"The BBMP has been making tall claims on its efforts to make Bengaluru a Smart City. What is the use of such claims if it is not able to fix a footpath?" asked Dyamannavar.

He explained that many BMTC commuters who want to alight near the Hebbal Flyover and board another bus to proceed towards Yelahanka and other areas have to walk on the footpath in question to reach the BMTC bus-stop opposite to the Esteem Mall.

"Water-logging happens on this road whenever it rains heavily. So, pedestrians neither walk on the road nor on the footpath when it rains. I want the BBMP to take measures to avoid water-logging on this road," he said.

Many pedestrians narrated how dangerous it is for them to walk on the footpath after sunset. They complained that they have to be wary of snakes that come onto the footpath from the waterbody.

"I want the authorities concerned whether it is the forest department or the BBMP to ensure walking on the footpath safe for pedestrians. It is nauseating and shocking to see the condition of this footpath. The BBMP has been spending crores of rupees on development of footpaths in the central business district (CBD) area. Why cannot the BBMP spend a few lakhs to

make this footpath pedestrianfriendly?" wondered Suresh Babu, a resident of Hebbal.

Meanwhile, deputy forest range officer Shivaraju S said he had informed the authorities concerned about the poor condition of the retaining wall and fence on the eastern side of the lake eight months ago. "As of now, no funds have been sanctioned for the development of this waterbody. I sent a proposal seeking funds for the restoration of the retaining wall and fence. I am yet to get a nod from higher authorities," Shivaraju said.

When informed about the ongoing development of a pond on the lake bund, he said the Palike has taken up the construction of an idol immersion pond. "The state forest department has nothing to do with the ongoing work at the idol immersion pond. We do not have funds to do any developmental work," he added.

he buzz among people in Kengeri and Kommaghatta, adjacent to Kengeri Satellite Town in West Bengaluru, is the roadworks happening there at lightning speed.

A huge playground is also being readied with big enclosures to accommodate thousands of people alongside two helipads.

Prime Minister Narendra Modi is to address a mega public meeting at the grounds in Kommaghatta on June 20 after a 12-km roadshow in parts of north and south Bengaluru.

The works began on June 13 and are scheduled to be finished by Friday (June 17). The Bruhat Bengaluru Mahanagara Palike (BBMP), Bangalore Development Authority (BDA) and Public Works Department (PWD) have been involved in a multi-pronged operation to complete the works before the deadline.

"We have to finish all the works and handover the playground area to the event organisers, central agencies, law and order, and traffic police. The BBMP's major roadworks department is laying newly asphalted roads on the stretch from Kengeri towards Kommaghatta as well as

However, there is still confusion and lack of coordination between the state agencies and us," said a central government employee inspecting the enclosures.

mid growing concern about a fourth wave of covid, Bengaluru, on Wednesday, reported 791 fresh covid cases, the highest in over four months. Last time the city witnessed over 700 active cases in a day was on February 17, when it recorded 705 cases. This was the time the covid-19 third wave was waning.

The city also recorded one death on Tuesday (June 14) after a long time taking the total death count to 16,966. While the positivity rate on June 15 was 4.3%, it was 3.5% with 615 active cases a day before.

With an uptick in the number of cases in the city, wearing a mask in public places has been made mandatory.

Experts say while the rise in cases might point to the onset of the fourth wave, there is no need to panic. This is because the severity of the disease is considerably lower from the first two waves.

"We see that a majority of the patients show symptoms for four to five days and most of them are recovering at home without major complications. This shows that the virus has become slightly weaker as opposed to what it had been in the beginning of the pandemic predominantly due to vaccination and natural immunity which has led to herd immunity," said Dr Sandeepa HS, pulmonologist, BGS Gleneagles Global Hospital.

They also pointed out that the virus is limited to small, isolated clusters. However, they stress the importance of adherence to covidappropriate behavior.

"While we are not expecting the fourth wave yet, however, the vulnerable section of the society, especially people with diabetes, multiple medical issues, and those who are not vaccinated must take precautionary meas-

ures. It is essential to follow the covid norms including using a face mask, social distancing, and hand sanitizers," said Dr. Satyanarayana Mysore, physician, Manipal Hospital.

They caution that the current positivity rate is based on the number of patients who are getting tested. However, there is a large section of individuals with symptoms of laryngitis, pharyngitis and of lower respiratory

tract infections who are not getting tested.

"Even if 1 to 2% of the affected population requires medical intervention due to complications, it will cause a burden to the healthcare system. Therefore, take necessary precautions, wear masks, continue social distancing and get yourself vaccinated. There is no need to panic and with this, we will be able to safely manage this wave," said Dr Sandeepa.

The body has prepared a draft delimitation report in which the wards have been reconstituted as per the 2011 census. It has been a week since the draft has been submitted to the state government. There has been no further action. While the draft is to be put out in public for consultation, the state government is yet to do it. Many activists are questioning the delay, alleging that it could be a ploy to delay the BBMP elections. As per the delimitation process, the ward boundaries are being redrawn where each ward may have an average population of 35,000 residents (plus or minus 10 per cent).

# Rain or shine, this road is just filled with muck

Soak pit dug by building owner overflows, throwing up sewage

t is not uncommon for the unpaved roads of outer Bengaluru to become slushy during the monsoon, but the main road of Meenakshi Layout, Hagadur Ward remains this way no matter the season.

For a whole year, harrowed residents have been in search of a permanent solution for this, but in vain. Navigating through potholes and craters on this road during the rains has become a part of life for them.

The Bruhat Bengaluru Mahanagara Palike (BBMP) is yet to take measures to asphalt the road despite repeated requests from the residents who have been paying property tax to the civic body. If monsoon woes were not enough already, they are also compelled to face overflowing sewage from a soak pit dug up by a high-rise building owner.

Residents complain that the building was constructed by violating bye-laws. It was also reportedly rented out to a contractor for sheltering around 100 people engaged in Metro construction work.

"We are not able to walk on this road. Many tenants have already vacated from our apartment complex due to this menace. Senior citizens, who want to visit nearby shops, are finding it difficult to walk on this road due to the overflow of sewage onto the road. We have complained to the building owner but nothing has been done to end this problem,"

said Kishore Reddy, president, Oasis Breeze Residents Association.

Sreenivas Reddy, a resident of Meenakshi Layout, said, "We have to take our children either on a twowheeler or four-wheeler to the main road as most of the school buses do not come to this layout due to the slush on the road. I hope the BBMP authorities take action against the person for this nuisance."

After getting tired of complaining to the BBMP authorities, the residents even approached the police seeking action against the building owner.

"We have complained to the authorities but nothing has been done to mitigate our problem. The building owner has rented the building to a contractor. There are around 100 people in the building. All of them have to attend to nature's call and have a bath. One can imagine the quantity of water being let into the soak pit. The building owner

claims that he has assigned a contractor to drain sewage water from the soak pit on a daily basis but overflow of sewage onto the road continues to be cause of concern for us," said JC Reddy, president, Meenakshi Layout Owners' Association.

Sujatha B, a teacher who is a resident here, said, "Stagnated water has become a breeding place for mosquitoes." Amana Church pastor Rajasekhar KP that around 600 devotees visit the church on Sundays and they are finding it tough to walk on the road. "It will be too tough for devotees in the monsoon to visit Amana Church because of the sewage problem. I have also advised the building owner not to let sewage onto the road, but in vain," he said.



## PM visit: 'Festival clean-up' for city

Reacting to the issue, a senior BBMP officer, not wanting to be named, said: "Whenever there is a festival at home, we clean the area and make it look good. It's the same ahead of the PM's visit. Improvement is being done so that Brand Bengaluru image is secure."

BBMP Engineer-in-chief Prahalad sought to play it down, saying road repairs are part of infrastructure improvement schemes, and are ongoing. Work has been prioritised and is being executed, he said.



## BBMP allocates ₹139cr for PMAY scheme

FOUR days after CM Basavaraj Bommai said that emphasis will be given to building one lakh houses for the poor in Bengaluru as part of the PM Awas Yojana (Urban), the BBMP has allocated ₹139 crore in its 2022-23 budget.

Dr Ramprasat Manohar, special commissioner for BBMP (estates), said the BBMP has allocated ₹28 crore to construct individual houses for pourakarmikas in the current budget. Each beneficiary will get about Rs 5 lakh. He said ₹55 crore was allocated for single houses under SC/ST scheme while ₹25 crore was for the backward classes and minorities, and ₹10 crore for specially abled people, who reside in the BBMP limits. He also said the tender process of garbage collection is ready and it will be processed after the bifurcation of wards.

### Beware! Viral infections on the rise in B'luru

Doctors blame it on weather changing rapidly, living conditions; kids bearing brunt of cold-related infections

WHILE Karnataka is yet to see monsoon in full vigour, viral infections are on the rise across the state. Doctors from both government and private hospitals in Bengaluru claim that there has been an increase in people approaching them with commonflu, leptospirosis, water-borne diseases like cholera and diarrhoea and even severe dengue cases.

severe dengue cases.
"We are seeing a spike in number of patients suffering from non-Covid respiratory infections, gastroenteritis and rashes. There are many patients suffering from dengue and den-



gue-like illness, having body ache, fever and low platelets," said Dr Suchismitha Rajamanya, Consultant, Internal Medicine, Manipal Hospitals, Whitefield.

With schools resuming in full swing, children are also bearing the brunt of cold and related infections. "Children were not exposed to several of these common respiratory viruses in the last two years as they were confined to their homes. Now with exposure to these virus it is common for children to fall sick and also bring the viral infections home. But parents should not panic," said Dr Ravi Mehta, Pulmonologist, Apollo Hospitals.

Meanwhile, doctors insist that not all infections need antibiotics. "Most patients are treated symptomatically and monitored regularly. The decision about starting relevant antibiotics is taken based on the symptom severity, clinical examination and lab investigations. Most of them are recovering uneventfully within 3-5 days," explained Dr Suchismitha.

BBMP's health department seems to have got a double whammy with Covid-19 and these viral infections to handle. However, Dr Thrilok Chandra, BBMP Commissioner (Health), said the Palike's health officials have been visiting slums and low-lying areas in the city and conducting tests to check for SARI/ILI patients. "If some is negative and if they have viral symptoms, then medicines

are given," he explained.

Doctors say that most viral infections in Bengaluru are on the rise due to weather conditions changing rapidly and living conditions.

"Civil and metro work across the city has led to unhygienic surroundings which is one of the reasons. To prevent viral infections, children and adults, especially the elderly, need to improve their immunity by having fresh fruits and vegetables and keep themselves warm and avoid exposure to extreme weather conditions," Dr Priti Shankar, General Physician, Apollo Clinic, Indiranaear.

# Advisory group recommends reducing gap for Covid booster jab to six months

A panel of the National Technical Advisory Group on Immunisation (NTAGI) on Thursday recommended reducing the gap between the second and the booster dose of the Covid-19 vaccine from the current nine months to six months for those above 18 years of age, official sources said.

The NTAGI's Standing Technical Sub-Committee (STSC) gave its recommendation to the Union Health Ministry, which will take the final call, official sources said.

The decision came amidst a spike in Covid-19 cases in some states in the past 15 days. India's Covid-19 vaccine coverage has exceeded 195.67 crores, till Thursday morning, as per Union Health Ministry data.

At the moment, all those above 18 who have completed nine months after administering the second dose are eligible for the booster or precaution dose. The Union Health Ministry last month allowed those travelling abroad to get the jab before the stipulated nine-month waiting period as re-

quired by the guidelines of the destination country. The members also discussed and reviewed the findings of a study by the Christian Medical College (CMC) in Vellore on the feasibility of allowing as a precaution dose a Covid vaccine different from the one used for primary vaccination. Officials said the panel found a lack of uniformity in results upon mixing of jabs for booster shots and stated that no recommensdation for it can be made as of now. The CMC study was on Covishield and Covaxin.

The panel, among other things, also discussed the

to control the fast-rising cases of monkeypox.

So far, no monkeypox case has been reported in India, with authorities issuing detailed guidelines for its prevention and control. Surveillance has been heightened at airports and ports.



## 144 m People had Long Covid Symptoms after 3 Months'

People suffered from 3 common symptoms – fatigue, cognitive and respiratory issues, finds a global study



New Delhi: Globally, 144.7 million people experienced one or more of three symptoms of long Covid—fatigue, cognitive problems and respiratory problems—three months after infection in 2020 and 2021, a new study has revealed.

The findings, published in medRxiv, a preprint server, are yet to be peer reviewed.

The persistence of symptoms has led experts to call for "rehabilitative care" and "support" to transition back into the workplace or education when symptoms start to wane.

"The study suggests that a high proportion of persons, including young adults (20-29 years), suffer from a cluster of symptoms for a longer duration. Specialist rehabilitative services are required to address mental as well as



disease-specific physical symptoms," said Giridhara Babu, senior epidemiologist.

"Returning to work and resuming routine activities is extremely challenging, at least in the shorter term, for the affected persons and they need specialised services to cope and recover. The study also shows that women and children are more vulnerable and need support while suffering from a cluster of symptoms."

Experts said the study is based on detailed information of 1,906 community infections and 10,526 hospitalised patients from the 10 collaborating cohorts, three of which included children.

"We added published data on 37,262 community infections and 9,540 hospitalised patients, as well as ICD-coded medical record data concerning 1.3 million infections," the study said. Researchers have found that globally, in 2020 and 2021, 144.7 million people suffered from any of the three symptom clusters of long Covid. This corresponds to 3.69% of all infections. The fatigue, respiratory and cognitive clusters occurred in 51.0%, 60.4%, and 35.4% of long Covid cases, respectively.

They found that those with milder infection had a quicker estimated recovery (median duration 3.99 months than those admitted for acute infection (median duration 8.84 months. At 12 months, 15.1% continued to experience symptoms of long Covid.

"The occurrence of debilitating ongoing symptoms of Covid-19 is common. Knowing how many people are affected, and for how long, is important to plan for rehabilitative services and support to return to social activities, places of learning, and the workplace when symptoms start to wane," the study said. According to Babu, there is a

According to Babu, there is a need for more sensitivity towards people facing such problems. "The health systems will have to look out for these manifestations and address them appropriately. Also, the workplace settings need to be accommodative, including providing adequate coverage and benefits," he said.

# Shanghai to Mass Test Whole City Weekly to Keep Covid at Bay

Beijing: Shanghai, which reported just 16 Covid-19 cases for Wednesday, will conduct mass testing drives every weekend until the end of July in the latest display of the lengths authorities are going to in order to maintain a zero-tolerance approach to the virus that's disrupting its economy and leaving it isolated.

A temporary lockdown will also be imposed on residential complexes where a Covid case is detected in the week leading up to the weekend testing, Zhao Dandan, an official with the Shanghai Municipal Health Commission, said at a briefing

dential complexes where a Covid case is detected

Wednesday. The lockdown will be lifted once everyone in the compound has been tested, he said.

In an effort to detect cases early and break transmission chains, the city's residents will need to take nucleic acid tests at least once a week until the end of July, with workers at supermarkets, barbers, drugstores, shopping malls and restaurants required to undergo daily testing. Delivery workers need to take both a nucleic acid and rapid antigen tests every day. Staff at banks, gas companies and industrial entities should also do an antigen test every day. Bloomberg



### US Recommends Covid Vaccines for all Children Under Five Years

Washington: A panel of experts convened by the US Food and Drug Administration unanimously recommended Covid-19 vaccines on Wednesday for children under five, the final age group awaiting immunization in most countries.

Formal authorisations for Moderna and Pfizer should follow soon, with the first shots in arms expected early next week, just over a year-and-a-half after the first Covid vaccines were greenlighted for the elderly in December 2020.

"This recommendation does fill a significant unmet need for a really ignored younger population," said Michael Nelson, a professor of medicine at the University of Virginia, one of the 21 experts asked to vote for the milestone meeting.

Unlike regulators in other countries, FDA offers livestreams of its internal deliberations and its stamp of approval is considered the global gold standard.

Opening the discussion, senior FDA scientist Peter Marks said that despite studies showing the majority of children have now been infected with the coronavirus, the high rate of hospitalisations among infants, toddlers and young children during last winter's Omicron wave underscored an urgent need for vaccination.

"We are dealing with an issue where we have to be careful we don't become numb to the pediatric deaths because of the overwhelming number of older deaths," he said.
