**R E P O R T**

***Introduction :***

As per the directions of Hon'ble High Court vide order dated 17.12.2020, the Karnataka State Legal Services Authority submitted Exhaustive Report regarding conditions of public street and footways within the limits of BBMP, Bengaluru.

On 30.03.2021, the Hon'ble High Court of Karnataka directed the BBMP Authorities to supply details of the roads and footpaths in respect of the claim made in

affidavit to the Karnataka State Legal Services Authority with specific locations of 101 roads and 642 footpaths as mentioned in page No. 7 and 9 of the affidavit. Further directed the Member Secretary of Karnataka State Legal Services Authority to visit the said roads and footpaths by making random selection and to ascertain whether claim made in the affidavit is true or not.

**STEPS TAKEN BY THE KSLSA :**

Pursuant to the directions of Hon'ble High Court vide order dated 30.03.2021, on 05.04.2021 the letter was addressed to Sri K. Siddegowda, Engineer in Chief, BBMP, Bengaluru with a request to furnish the details of 101 roads and 642 footpaths with specific locations as directed by the Hon'ble High Court of Karnataka. **(Annexure-A)**. On the same day the Chief Engineer (Road Infrastructure), BBMP, Bengaluru supplied the details regarding 75 major roads and 371 footpaths issues as directed by the Hon'ble High Court. Further they stated in their letter that the Zonal wise information may be

received from Sri K. Siddegowda who is incharge of Zonal Ward Engineering Works.

On 07.04.2021, the Member Secretary, KSLSA convened a meeting with the Para Legal Volunteers, NGOs, Advocates and Civil Society Organizations regarding directions issued by the Hon'ble High Court and with their help KSLSA could do random selection of roads and footways as directed by the Hon'ble High Court **(Annexure-B)**. Again on 08.04.2021 the letter was addressed to Sri K. Siddegowda, Engineer in Chief, BBMP, Bengaluru to furnish the consolidated information as directed by the Hon'ble High Court without any delay. **(Annexure-C)**. Inspite of letter correspondence and through telephone conversation the BBMP Authorities have not supplied the consolidated information as directed by the Hon'ble High Court. However, on 07.04.2021 and 08.04.2021 the Chief Engineer of East Zone and Dasarahalli Zone respectively furnished the information regarding potholes and footpath issues attended in Zonal

Wards. Then belatedly on 19.04.2021 at about 4.30 pm the Chief Engineer, BBMP, Bengaluru furnished the details of ward roads and footways of remaining other Zonal Wards to KSLSA. On 21.04.2021, the Member Secretary and his team inspected the potholes and footways in East Zonal ward. As the consolidated information was received at the fag end, it was not possible for us to inspect all the ward roads.

The Member Secretary, KSLSA and his team visited Bommanahalli Zone on 11.04.2021 and on 12.04.2021 visited R.R. Nagar Zone. During the visit it is found that the claim made by the BBMP is not fully correct and the photographs as furnished by the BBMP are not tallying with the issues identified by the KSLSA. In view of the same on 15.4.2021, a letter was addressed to Engineer-in-Chief, BBMP, Bengaluru to direct the concerned officials be personally present during the inspection in their respective zones. **(Annexure-D)**. In response to the said letter the Executive Engineers and Assistant Executive

Engineers were present during inspection of South Zone, East Zone, West Zone, Yalahanka Zone, Mahadevapura Zone and Dasarahalli Zone. In their presence only the inspection was conducted.

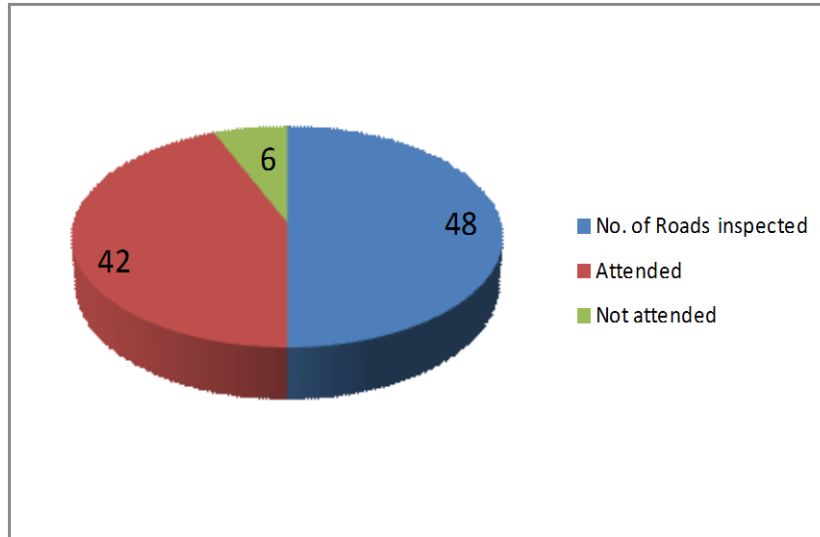

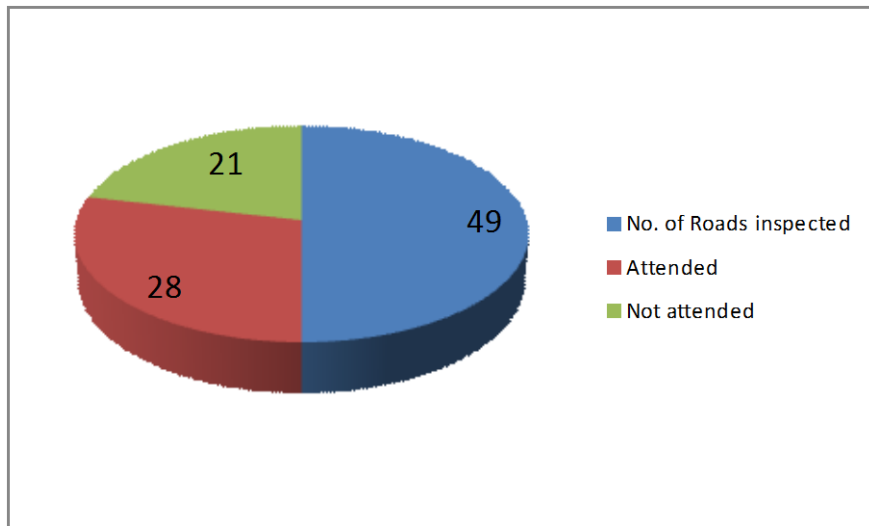

**(Annexure-E&F)**

It is respectfully submitted that in the compliance report submitted by the BBMP they have only concentrated the potholes and footways issues identified by the KSLSA in its report dated 05.02.2021. The 437 pothole issues and 4998 footways issues (totally 5435) are only the examples to show the conditions of the BBMP roads and footways after conducting random inspection of few BBMP roads. Those 5435 issues are identified by the KSLSA just to indicate the condition of the roads and footways. It is not an exhaustive report to show the condition of BBMP roads and footways in the entire BBMP area.

Therefore, while submitting compliance report the BBMP ought to have mentioned the repairing work done in the road taking clue from the report of KSLSA. During our inspection, it was found that BBMP had attended only those issues which are identified by the KSLSA in its report, but not attended the other pothole and footpath issues in the same area.

Hence, it is kindly submitted that the claim made by BBMP in its affidavit is not fully correct. Therefore necessary directions may be issued to BBMP to complete its work throughout in all major roads and ward roads as shown in KSLSA report.




