The agency must restore the pits on the same day itself so as to make the road motorable for moving traffic. Any delay in this regard is liable for Penalties as per order of Hon'ble Commissioner, BBMP.

Permission will be accorded with all applicable, necessary conditions after submission of the Demand Draft drawn from Nationalized Banks, for the above mentioned amount to this office.
