With reference to your application for Regularization, we have pleasure to inform you that permission given for regularized poles has been given on the roads mentioned below.

SI No	Name of the Road and Route	No of Poles
01	Permission for Regularization for poles from the junction of Street ID No-W0903 along Balagere Main Road up to junction of Street ID N-W0295 for total No of 18 Poles, in Ward No-149, Mahadevapura Zone. Ref: As per drawing enclosed & demand note GIS co-ordinates.	18 Poles

Special Condition:

COVID -19 guide lines to be followed without fail and all requisite permissions from Police department/Labour department/ Health department/ or any other department as applicable shall be obtained and a copy of the same to be retained at every work site without fail.

Conditions for Regularization of Poles

1. The pole should have been installed within the stretch where OFC cable has already been installed. The permission details of OFC cable shall be uploaded in the space provided for.
2. The pole should be used only for last mile connectivity. They should not be used for overhead cable laying or for crossing the road.
3. The pole shall be at a minimum distance of 0.3 mtrs from the edge of the walk way of road (road berm) and shall be installed in concrete foundation.

4. The junction box and the OFC cable and the sag of the OFC cable shall be at a minimum height of 5 mtrs above the ground, roads or flyover and shall not interfere with the movement of the vehicles or the pedestrians.
5. The height of the pole shall be such that it doesn't interfere with the electrical cables and distribution system.
6. The minimum distance between two poles shall be 40 mtrs.
7. The rectified portion of the road shall be maintained for 2 years from the date of sanction.
8. The agency shall take all precautionary measures to maintain the eco system and aesthetics of that area, while installing the pole or the pole shall be removed from the that place.
9. The terms and conditions or guidelines issued or notified by the Department of Telecommunications, Government of India in respect of any condition applicable to the agency, as amended from time to time, shall be applicable and binding in all cases.
10. In case of any shifting or change in position of the already laid pole is necessitated due to widening of roads or construction of flyovers or public building, the agency shall be bound to do the same at its own cost within the period specified by the respective authority. If the agency fails to comply with this condition to the satisfaction of the said authority, the same shall be got executed by the said authority at the risk and cost of the agency. The charges so incurred on this account shall be recoverable from the agency.
11. In case of removal of already laid pole on expiry of period granted, the agency shall be bound to do the same at its own cost within the period specified by the competent authority. If the agency fails to comply with this condition to the satisfaction of the competent authority, the same shall be got executed by the competent authority at the risk and cost of the agency. The charges so incurred on this account shall be recoverable from the agency.
12. The corporation shall not be responsible for any damage to poles and resultant losses, if any during performance of official duties by any employee of corporation.
13. Any dispute arising between the signatories to an agreement under these rules shall be settled or resolved in accordance with the procedures outlined in the MOU i.e, all the disputes shall be settled at the level of BBMP competent authority as the case may be. In case of breach of any of the clauses of the agreement, the competent authority shall be entitled to terminate the contract after giving a show cause notice of fifteen days. If any dispute arise it will be settled as per the MOU.
14. Operational and maintenance activities in respect of poles shall be under taken with prior intimation to jurisdictional officers. No fresh permissions are necessary for purely operational and maintenance activities.
15. The Concerned appropriate authority may, on the basis of such supervision, impose such other reasonable conditions, as it may think fit.

16. The permission holder shall not remove or translocate poles without the prior approval of the concerned appropriate authority.
17. In the event the local authority/Urban Local Body or any other agency of the State Government or Central Government seeks to widen or modify the roads abutting which poles of the permission holder exists, such permission holder shall coordinate with such agency for removal or shifting of poles.
18. In case of any untoward incidences or accidents arising due to negligence on the part of permission holder in erecting poles, the jurisdictional officer shall initiate criminal proceedings against the permission holder and take necessary action as per law, in addition to levy of penalty.
19. The buffer to be maintained from various water bodies including rivers, tanks, Kuntas, Canals, Nalas, Storm Water Drains, for installation of poles shall be as prescribed by Government from time to time.
20. **Railways:** The distance between the Railway Property Boundary and the poles shall be 30m as per Indian Railways Works Manual or as per no objection certificate given by the Railway Authorities.
21. **Electrical Lines:** The right-of-way widths recommended for electrical lines of various transmission voltage are as indicated in the table below:

Distance of site from Electric Lines. -No pole shall be allowed to be erected or re-erected or any additions or alterations made to poles in a site within the distance quoted below in accordance with the current Electricity Rules and its amendments from time to time between the poles and any overhead electric supply line;

24. In the reserved forest or forest areas: for erecting the poles, NOC from the Forest Department shall be submitted.
25. Every pole shall be marked with permission details of the pole in bold and clearly visible form.
26. The agency shall abide by all the terms and conditions laid in these rules.
