11. After the completion of the rectified portion of the subject road, the same should be maintained for 2 (two) years.
12. After completion of the work, as per specification given by BBMP, the Agency must get a Satisfactory Work done Certificate from the jurisdictional BBMP Engineers After the DLP (Defect Liability Period) of 90 days a satisfactory completion and maintenance Report/Certificate by the jurisdictional BBMP Engineers should be furnished to this office to enable release of the Security Deposit.
