PREAMBLE :-

The Government of India vide Ref(1) and (2) have accorded the (Stage-I) and (Stage-II) Approval under section 2 of the Forest (Conservation) Act, 1980 for Diversion of 18.11 ha of Forest land in Sy No. 1 of Kadugodi Plantations, Bengaluru East Taluk (K.R.Puam Range), Bengaluru Urban District and Division for Construction of approach to Depot in favour of General Manager(LA&E), Bangalore Metro Rail Corporation Limited (BMRCL), Bengaluru in reference(1)&(2) as cited above.

Bangalore Metro Rail Corporation Limited had submitted the application for tree felling to this office for construction Purpose of various Metro Rail Projects in Diversion of 18.11 ha of forest land in Sy. No.1 of Kadugodi Plantations, Bengaluru East Taluk. in reference (3) cited above. There are trees which are hindering BMRCL Metro Rail works, the user Agency has submitted application for removal of trees. Public hearing had been done on dtd:13-12-2019 and proceedings has been drawn. The press Notification regarding this was notified in Vijayavani News paper dated 11-12-2019 The Range Forest officer, K.R.Puram Range and Assistant Conservator of Forests, Bangalore South Sub-Division has submitted a report along with enumeration list of trees in ref (4) & (5).

In deference to the orders of the Hon'ble High Court of Karnataka in W.P.No. 17841/2018 (PIL) Dtd: 04.03.2020 in ref (6) the enumerated List had been submitted to the Re-constituted Tree Expert Committee, as per the orders of the Hon'ble High Court. The Committee examined the reports submitted by Member Secretary and Assistant Conservator of Forests, Bruhath Bangalore Mahanagara Palike, Bengaluru and carried out field

visits for on-site assessment of trees infringing BMRCL Metro works at Kadugodi Plantations on 17.09.2020 and inspected the said trees .

As per the Proceedings drawn by the Tree Expert Committee dated:14.10.2020 regarding Retention/Translocation/Felling of trees has been communicated by Member Secretary and Assistant Conservator of Forests, BBMP vide reference (8) cited above(**Annexure-I**) to the Tree officer and Deputy Conservator of Forest, Bangalore Urban Division for needful action; Hence the order.

ORDER

Based on the orders of Hon'ble High Court of Karnataka Dtd. 04.03.2020, and the proceedings of the Tree Expert Committee Dtd. 14.10.2020, the orders on Retention/Translocation/Felling of tress are issued as stated below and the details are enclosed as Annexure-II.


The above orders will come into effect after 15 days from the date of uploading it in the website of BBMP, and have to be executed subject to the following conditions.

Conditions in respect of Felling of trees: -

1. The wood extracted would be transported and disposed off as per the Forest Department Rules at the cost of BMRCL.
2. Compensatory plantations saplings in the lieu of felling of trees at a ratio of 1:10 will be carried-out with post care management for three years by Forest Department.

Conditions in respect to Translocation of trees: -

1. The BMRCL shall translocate the trees at its own cost to the locations approved by TEC and shall be maintained for a further period of three years from the date of translocation, through experienced agency and under the technical supervision of the Forest Department.
2. The BMRCL to furnish the name and address of the Person/Agency to whom the work of translocation is entrusted in its letterhead.
3. The Translocation of trees shall be executed as per guidelines /Methodology by GKVK Committee and TEC. Photographs and video of the translocation process should be submitted to this office through CD, after the completion of work.
4. Regular post care management of the Translocated trees should be undertaken, so that these trees survive successfully. The staff of Forest Wing shall visit the spot to assess the progress achieved by the user Agency.
5. All the necessary permissions for access for translocation of trees by Agencies/BMRCL officials shall be provided by Forest Department.
