

The allocation is made applicable till further orders with the conditions mentioned in Remarks column. Following conditions are to be followed further-

1. a. The Joint Commissioner East & West Zone should prepare the scientific landfill facilities as per MSW rules at Bagaluru & Mitaganahalli respectively & ensure that waste is transported to such facilities from 01.06.2016,
b. The Joint Commissioner South Zone should ensure creation of the scientific landfill facilities at Gollahalli as per MSW rules within 7 days.
2. The Zonal Joint Commissioners/CEs have to strive hard for 100% segregation as early as possible and take all necessary measures to ensure above.
3. Zonal Commissioners/CEs should ensure disposal of Wet, Dry, Mixed waste & Domestic hazardous waste (sanitary etc.,) to different places as per various directions. The vehicles should be fully loaded ensuring non spillage of leachate.
4. Zonal Commissioners/CEs should issue vehicle number wise orders as per above allocation informing the concerned plant operators in advance to make necessary arrangements and appoint nodal officers for each destinations by the concerned zonal JC managing the plant and send a copy to the Head Office.

5. Contractors/Transport Agency needs to be informed to ensure proper cleanliness of compactors, spraying of lemon grass to reduce smell before sending to plants and also not to deviate from above routing and follow the rules strictly and failing which they would be heavily penalised for any deviation as well as unloading anywhere else.
6. Daily report on unloading destination-wise should be submitted by the concerned CEs/SEs of each zone to HO. During the festival season, proper care has to be taken to ensure non-acumulation of garbage on the streets by ensuring complete loading of the garbage transport vehicles.
7. Zonal Commissioners/CEs must plan ward wise and transport vehicle wise proper routing and disposal of vehicles to ensure smooth flow and lifting of waste.
8. Zonal Commissisoners/CEs can bring above plan to the notice of Elected representatives as well as general public.
9. **Zonal Commissioners/CEs/SEs should ensure payments for the compactors/tipper lorries based on the confirmation report of disposal of waste from such vehicles at the allocated destinations only.**

Above directions are to be strictly followed. Any deviation will attract disciplinary action. Allocation comes into effect from 01-06-2016. By 31-05-2016 all the Zonal Joint Commissioners should allocate the ward wise vehicles to the plants as per the capacities allotted & submit details to head office and ensure that orders reach the concerned plant operators and all the concerned.
