

2) Duties of the officer and the staff

1. Physician:

- a) Duty begins at 9 am.
- b) Will see to that the hospital opens before 9 am.
- c) Monitoring the duty of ayah and P.K to ensure that the hospital is clean and maintained properly.
- d) Treating out patients and dispensing medicines.
- e) Do all the administration work of the hospital.
- f) Do all the national health programs like pulse polio etc.
- g) Attending to all epidemic diseases like Chikungunya and Swine flu.
- h) Attending medical camps.
- i) Attending monthly meetings

2. Pharmacist:

Medicine stock and issuing.

3. **Attender**: (vacant)

Be present before the hospital time and open the door and clean the hospital.

4. **P.K**:

Helps ayah in cleaning the hospital. Carrying tapal and performing the duties as per the instruction of the doctor.

5. Night Watchman:

Maintains dispensary security at night time.
