CIRCULAR No.9

Subject: Insurance to the plants

The newly constructed waste treatment plants have already been commissioned and regular operation & maintenance is being carried out by the Operators. As such, it is essential to take necessary insurance for the safety and security of these plants.

In this regard, it is informed that as per General Conditions of the Contract, Clause No 3.4 of the agreement the "Operator (a) shall take out and maintain, and shall cause any Sub-Contractors to take out and maintain, at their (or the Sub-Contractors', as the case may be) own cost but on terms and conditions approved by the Employer, insurance against the risks, and for the coverage, as shall be specified in the SC; and (b) at the Employer's request, shall provide evidence to the Employer showing that such insurance has been taken out and maintained and that the current premiums have been paid".

Further, it has also been made clear in the Special Conditions of Contract, Clause No. 3.4 of the agreement that "insurance against loss of damage to equipment purchased in whole or in part with the funds provided under this contract and for assets handed over by the Employer needs to be obtained by the Operator".

Needless to say, compliance of above contract provisions is paramount to ensure plant and machineries sufficiently protected from any kind of eventuality either natural or manmade.

Hence you are hereby directed to obtain necessary insurance as per conditions of contract.
