


WHEREAS:

- A. The contractor had applied for the VDA and the same was approved by the superior authority.
- B. Hence effective 1st of January 2015 the BBMP agrees and undertakes to pay to the service provider a fee of **Rs. 32,15,487.00 (Rupees Thirty Two lakhs Fifteen Thousand and Four Hundred Eighty Seven Only)** per month.
- C. The Contractor should adhere the following conditions strictly:
 - 1) The contractor shall produce ESI and PF details of each of the employee and receipt for having paid ESI & PF contribution for each month.
 - 2) The agency shall produce necessary receipt/acknowledgements for having distributed this VDA to the concerned within 15 days after receipt of payment.
 - 3) The supplier shall restrict the claim to the actual number of working days of PKs during that particular month.
 - 4) The concerned AEE's shall certify in the DC bill indicating that claims are in accordance with attendance and equitorial role.
 - 5) 3% escalation charges are admissible only once during the contract period.
 - 6) Rest of the other conditions remain the same as per work order and agreement made on 27-06-2013.



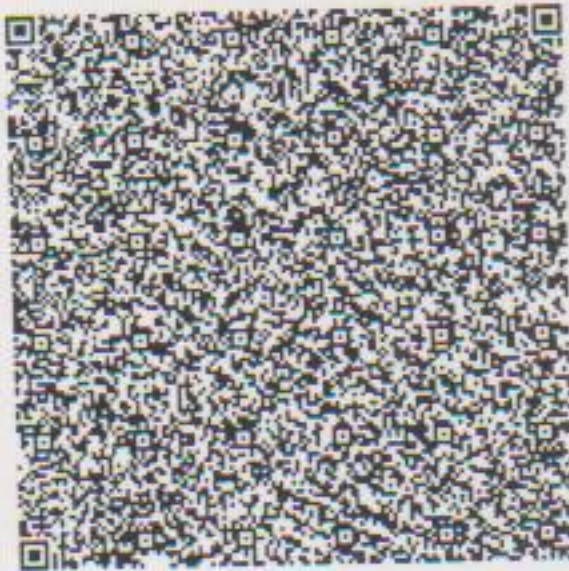
